UNIT 1 WAS TRAVELING SOUTH ON SR 8 DIRECTLY BEHIND UNIT 2. UNIT 2 WAS TOWING A FLATBED TRAILER THAT WAS DROPPING DEBRIS ON THE ROAD. AS THE DEBRIS STRUCK UNIT 1, UNIT 1 SLOWED DOWN TO CREATE DISTANCE. AFTER UNIT 1 SLOWED DOWN A LARGE PIECE OF DEBRIS FELL OFF THE TRAILER AND STRUCK THE WINDSHIELD OF UNIT 1 CAUSING DAMAGE TO THE WINDSHIELD.

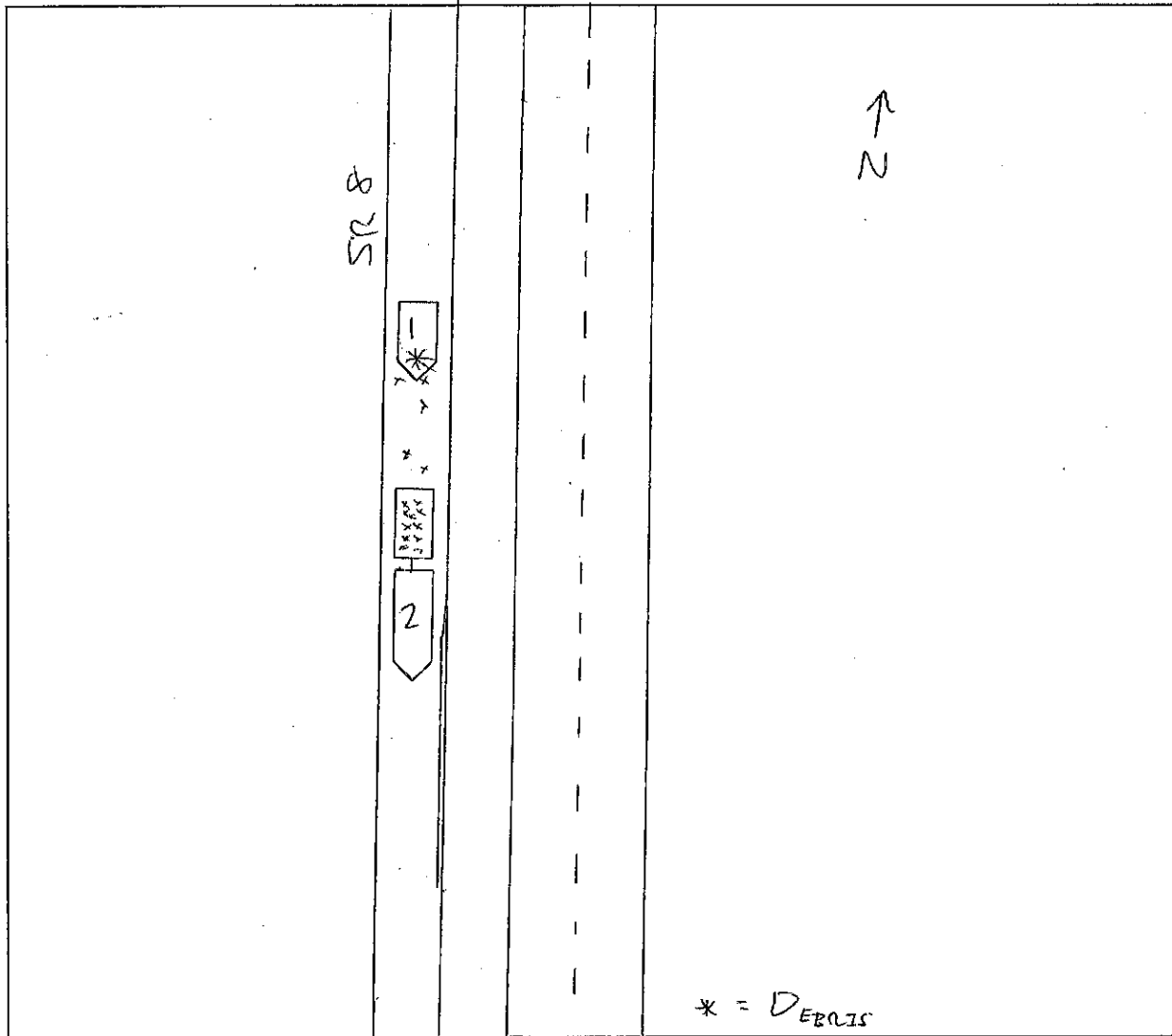
