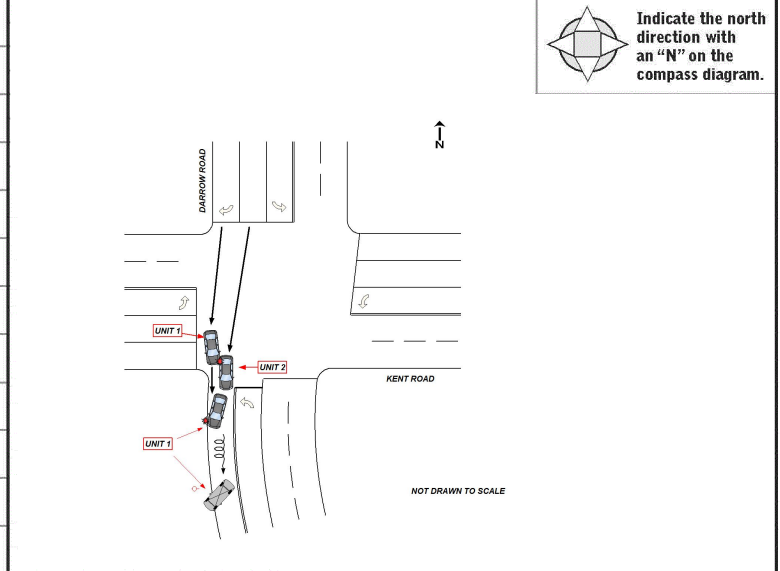

NARRATIVE

Unit one and Unit two were stopped at a traffic signal southbound on Darrow Road at Kent Road. Unit one was in the right-turn lane and Unit two was in the middle lane. Once the signal turned green, Unit one attempted to change lanes into the middle lane. Unit one struck Unit two in the rear passenger side tire, then struck the westside curb, causing Unit one to overturn. Driver of Unit one left the scene on foot, but was quickly apprehended by witnesses and officers.

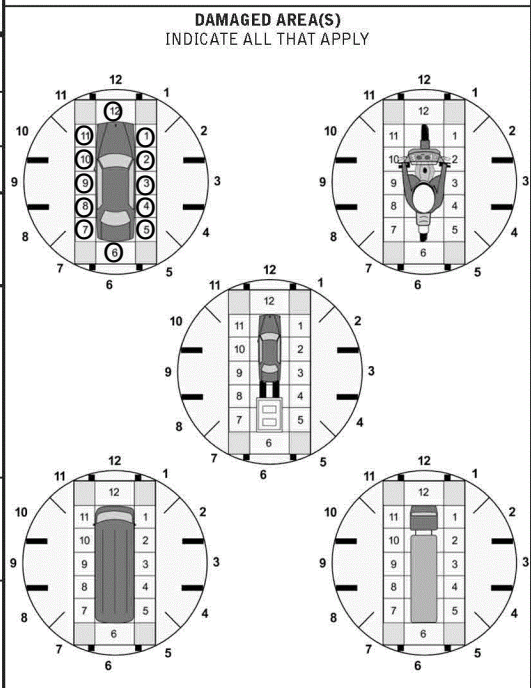

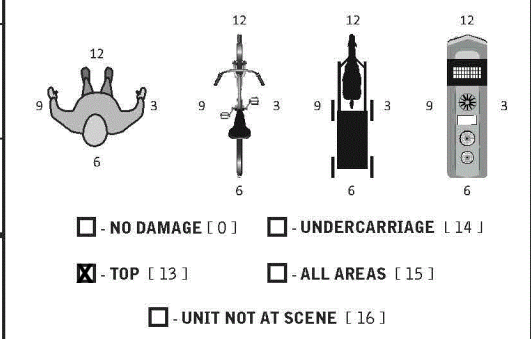
