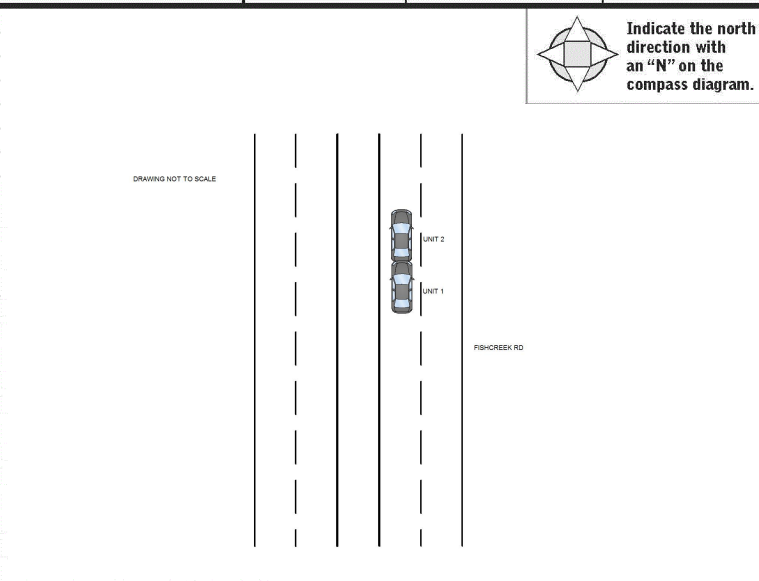

NARRATIVE

Both units agree Unit-1 was behind Unit-2 and both were n/b on Fishcreek Rd approaching Fire Station 3. Unit-2 came to a stop due to all of the traffic in front of her that came to a stop first. Unit-1 states that she heard sirens and was checking the surrounding area to make sure it was clear prior to safely pulling to the right safely. Unit-1 failed to maintain assured clear distance ahead and struck the rear of Unit-2 causing minor damage to both vehicles. Unit-2 was not medically treated at the scene for injury but advised that she may follow up for soreness.

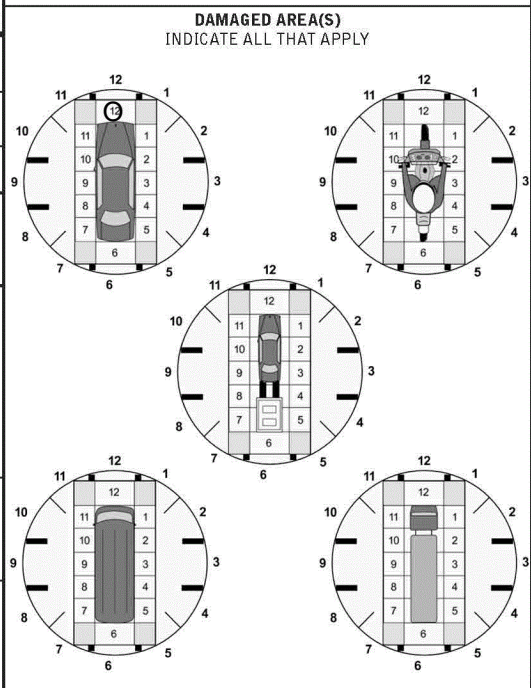

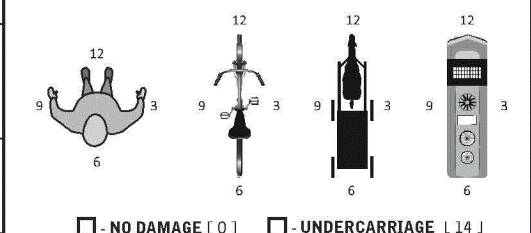

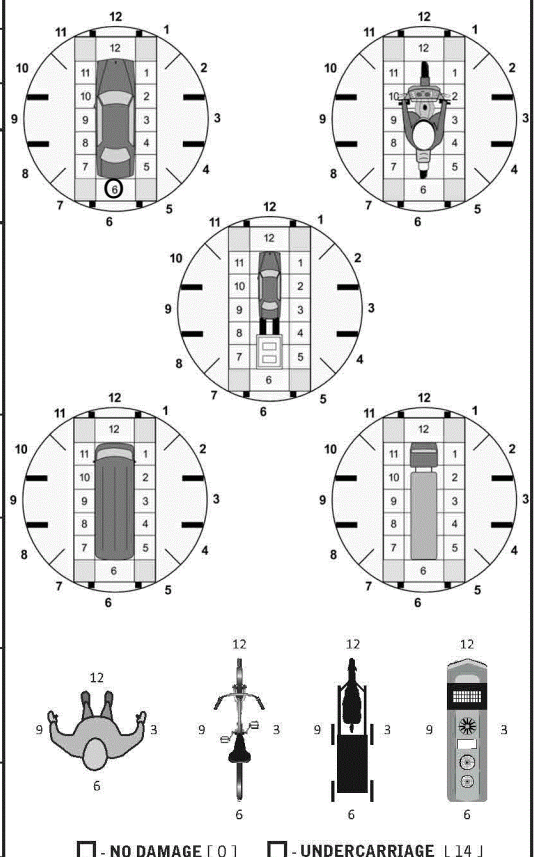
