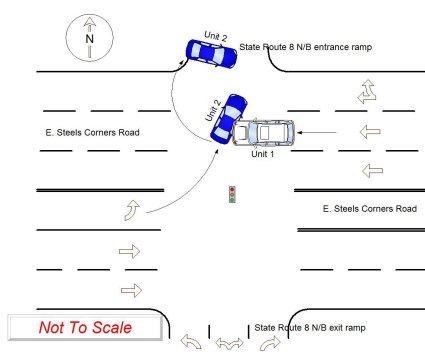
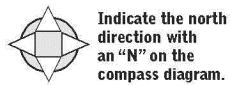

Both units stated the intersection traffic signal had just changed to yellow as they entered the intersection. Unit 2 failed to yield to Unit 1 and the units collided in the intersection. Unit 2 then struck the curb and went off the left side of the roadway.**

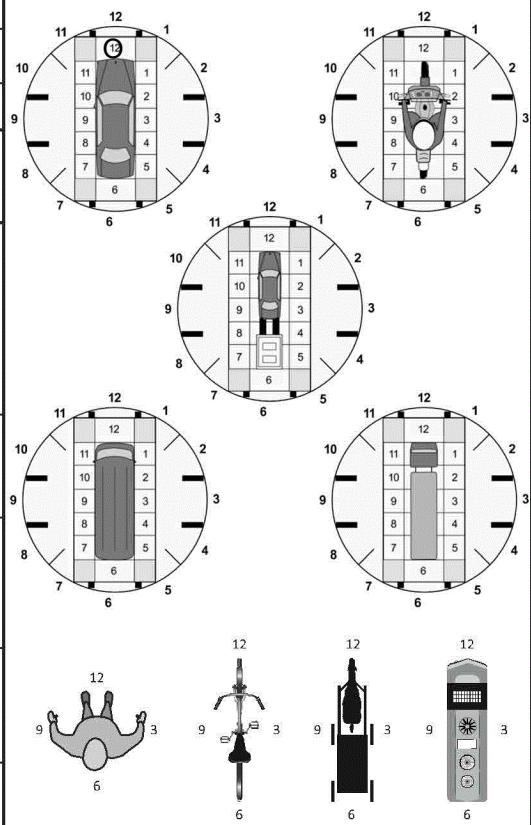

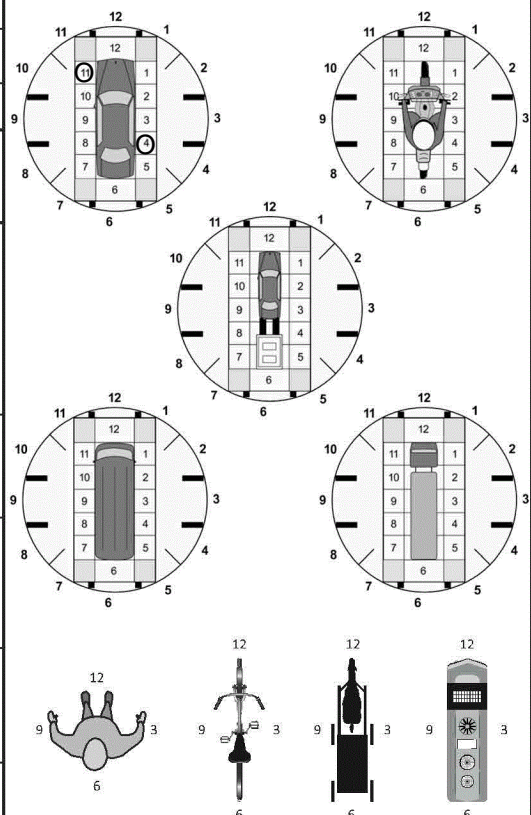


