

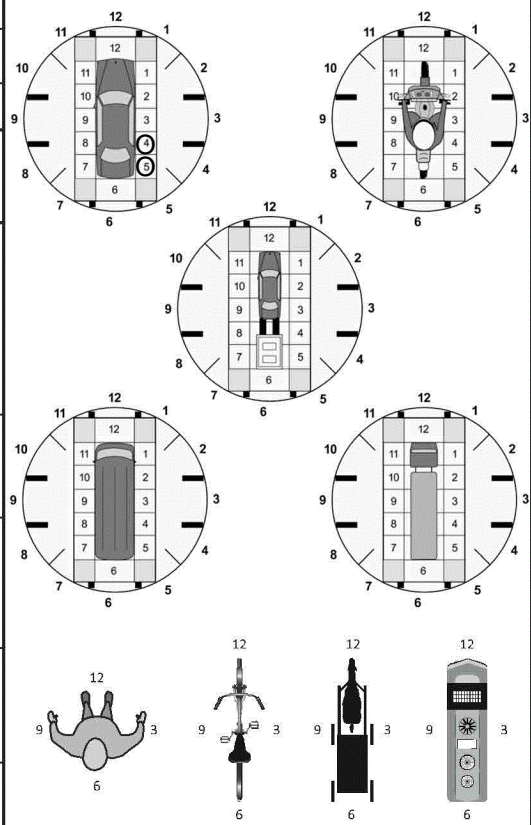

UNIT 1 AND UNIT 2 WERE BOTH ORIGINALLY ON THE EXIT RAMP FROM SR 8 NB TO GRAHAM RD. UNIT 1 WAS IN THE FAR LEFT LANE. UNIT 2 WAS IN THE MIDDLE LANE.

BOTH UNITS THEN TURNED LEFT TO ATTEMPT TO PROCEED WB ON GRAHAM RD. THE TURN LANE AT THAT INTERSECTION IS CLEARLY MARKED WITH PAVEMENT LANE MARKINGS.

UNIT 2 CLAIMS UNIT 1 CAME INTO HER LANE SOMEWHERE ON GRAHAM RD TO CAUSE THE CRASH. SHE ALSO SAID THAT WHEREVER THE POINT OF IMPACT WAS THAT SHE "WAS ALMOST PUSHED INTO A GUARDRAIL". UNIT 2 THEN STATED UNIT 1 DID NOT STOP AND WAS NOW IN HER LANE HEADED WB. UNIT 2 TOOK A PICTURE OF THE REAR OF UNIT 1 TO DOCUMENT THE PLATE. UNIT 1 THEN STOPPED WITH UNIT 2 NEAR GRAHAM RD @ HUDSON DR.

WHILE INVESTIGATING THE CRASH, I ASKED UNIT 1 WHAT HAPPENED AND SHE COULD NOT RECALL. SHE STATED SHE HAD BEEN HEADED TO WALMART BUT COULD NOT RECALL THE ACCIDENT.

THERE ARE NO CAMERAS NEAR THE ORIGINAL INTERSECTION. I INFORMED BOTH DRIVERS THAT THERE WOULD BE NO CITATION SINCE I COULD DETERMINE FAULT. I EXPLAINED TO BOTH DRIVERS THAT I WAS UNABLE TO DETERMINE WHERE TH CRASH HAPPENED AND HOW IT HAPPENED.

UNIT 2 WAS NOT SATISFIED WITH THIS AND ASKED TO SPEAK TO LT. TITUS, THE DAYSHIFT SUPERVISOR AT THE TIME. SHE EXPLAINED HOW SHE FELT THE CRASH HAPPENED TO HIM. WE MANAGED TO GET UNIT 1 TO COME BACK TO THE SCENE. UNIT 1 STILL COULD RECALL HOW THE CRASH ORIGINALLY HAPPENED.


UNIT 1 FELT THAT SHE WAS "REAR ENDED" BY UNIT 2. UNIT 1 WOULD NOT ADMIT TO CHANGING LANES SINCE SHE HAD ADMITTED ORIGINALLY TO BE HEADED TO WALMART. SHE CONTINUED TO SAY THAT SHE WAS "READ ENDED". SHE STATED SHE DROVE WB ON GRAHAM RD. TO FIND A PLACE TO PULL OVER AT.

THE MANNER AND LOCATION OF THE CRASH IS IN QUESTION. DUE TO BOTH STORIES BEING UNABLE TO BE VERIFIED, I DID NOT LIST A UNIT AS AT FAULT.

I ALSO WALKED TO ALL OF THE BUSINESSES IN THE 1000 BLK OF GRAHAM RD TO INQUIRE ABOUT ANY CAMERA FOOTAGE. THERE WAS NO CAMERA FOOTAGE AVAILABLE.

HERE ARE SEVERAL SCENARIOS TO EXPLAIN THE CRASH WHERE EITHER DRIVER COULD BE AT FAULT, 1. THE CRASH COULD HAVE HAPPENED WHILE BOTH CARS TURNING LEFT ONTO GRAHAM RD WHERE EITHER CAR COULD HAVE GONE OUTSIDE OF ITS LANE, 2.
