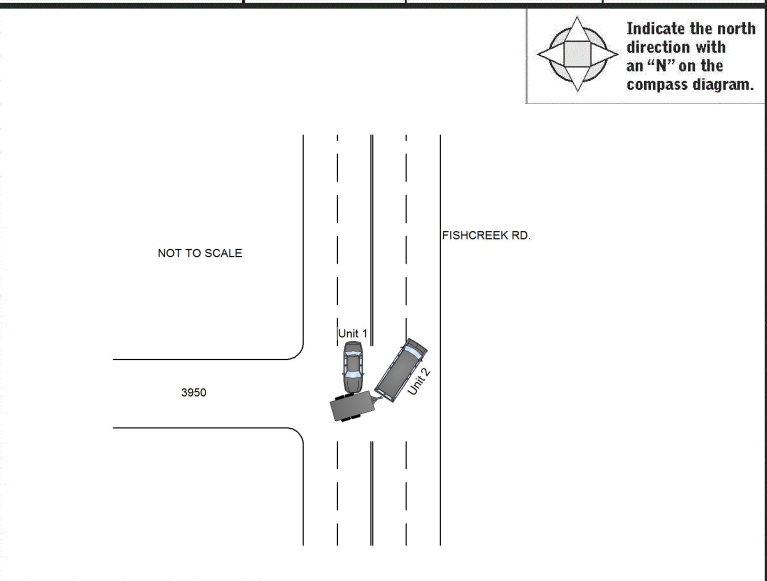

UNIT #2 FAILED TO YIELD THE RIGHT OF WAY TO ONCOMING TRAFFIC AND PULLED OUT IN FRONT OF UNIT #1 AND STRUCK THE FRONT OF UNIT #1 WITH THE LEFT SIDE OF ITS TRAILER.
