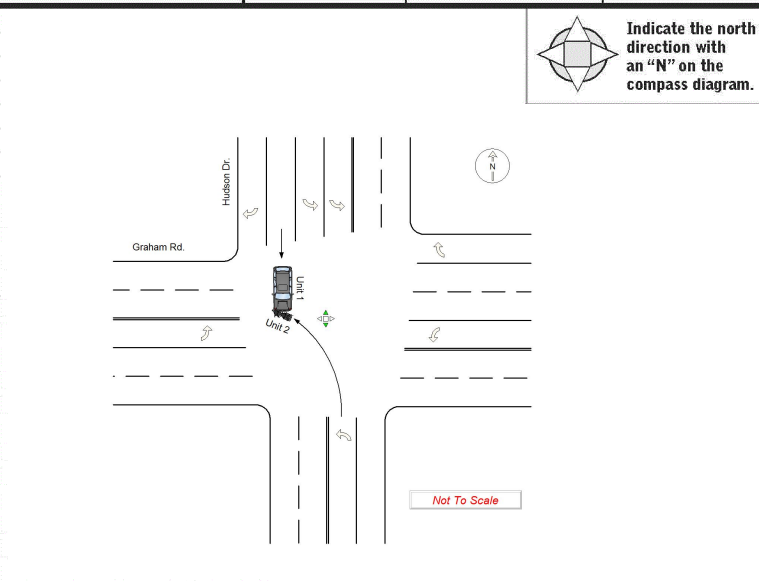

Unit 1 was traveling south on Hudson Dr approaching Graham Rd. Unit 2 was traveling north on Hudson Dr attempting to make a left turn to travel west on Graham Rd. As Unit 1 approached the intersection to continue south on Hudson Dr, the vehicle in front of Unit 2 made their left turn onto Graham Rd. Unit 2 then proceeded to follow that vehicle, failing to yield to the right of way when making a left turn. Unit 1 then struck Unit 2.

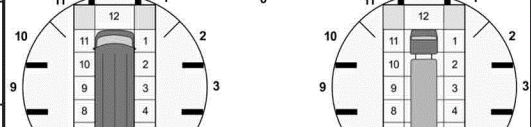


WAS VEHICLE OPERATING IN AUTONOMOUS MODE WHEN CRASH OCCURRED? **2**

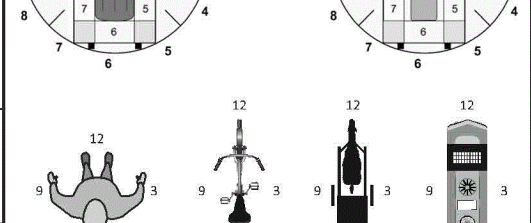

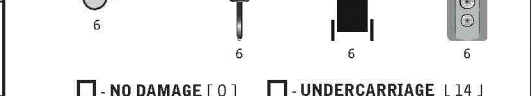

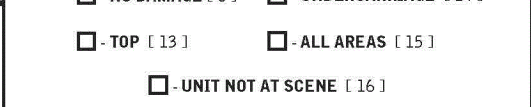
