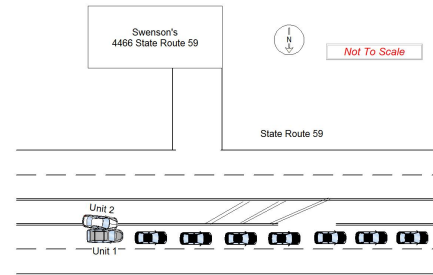
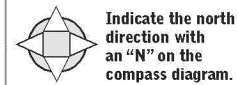

Unit #1 was stopped in the left straight lane near 4466 State Route 59 waiting at a red light at the intersection at Marsh Road. Unit #2 got into the left turn lane to make a left into the parking lot at 4466 State Route 59. When attempting this maneuver, Unit #2 left the turn lane and struck Unit #1, who was still completely stopped. The driver of Unit #2 was unsure which lane the accident occurred in or how it happened.**

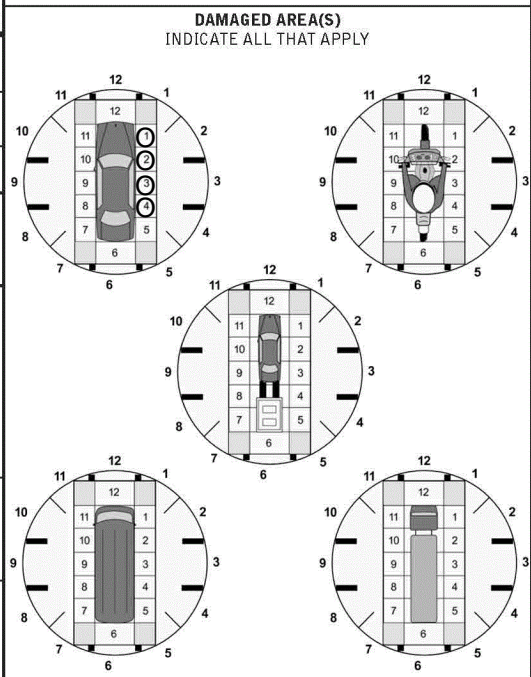
