Unit #1's driver attempted to get him to stay while he called the police. He jumped in his van and fled, never giving Unit #1 his information. A passenger in Unit #1 took photos of the suspect who does not match the registered owner.

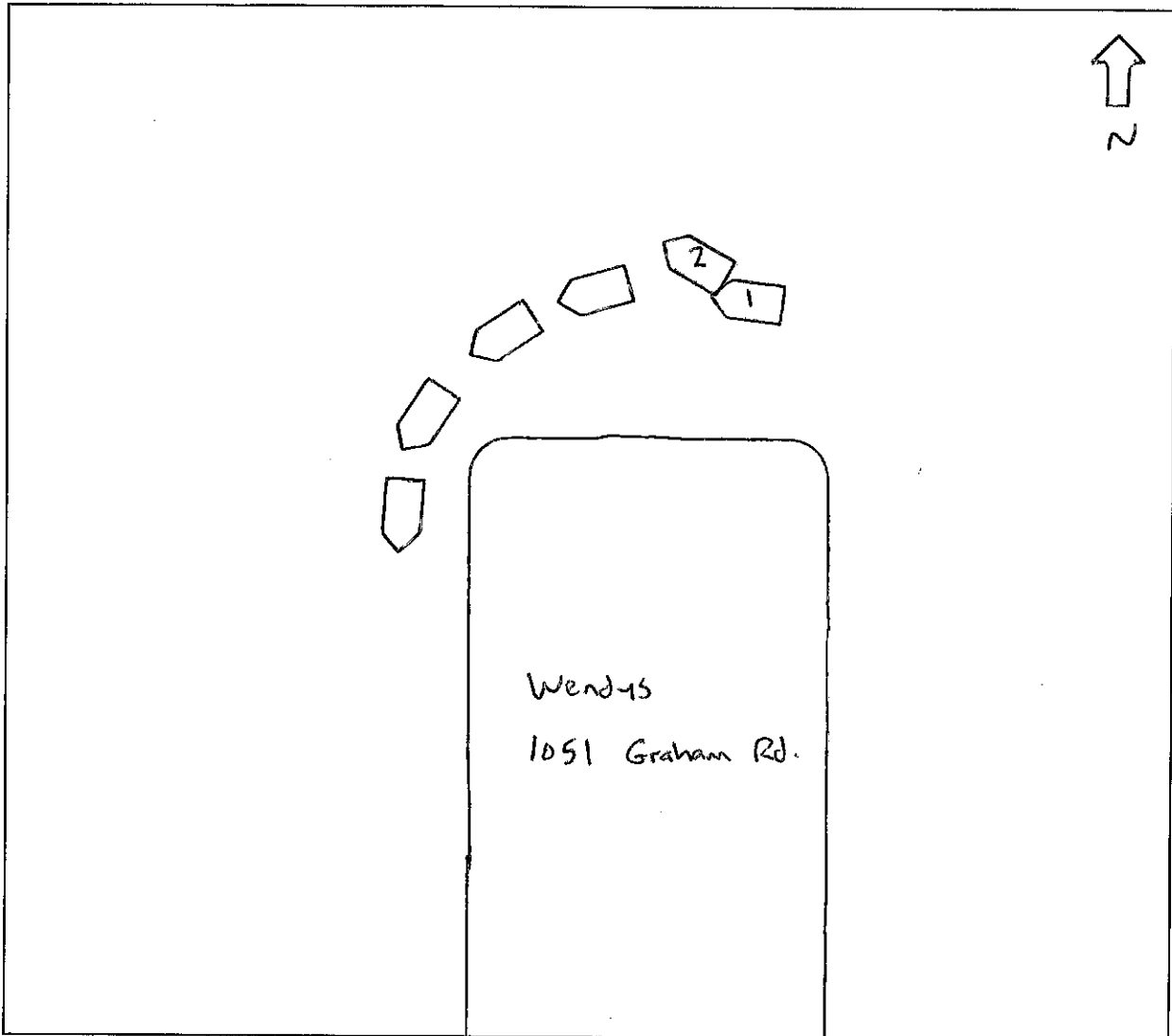

I advised William the owner of Unit #12 lives in Cleveland. He advised the damage was minor and he did not need this followed up.
