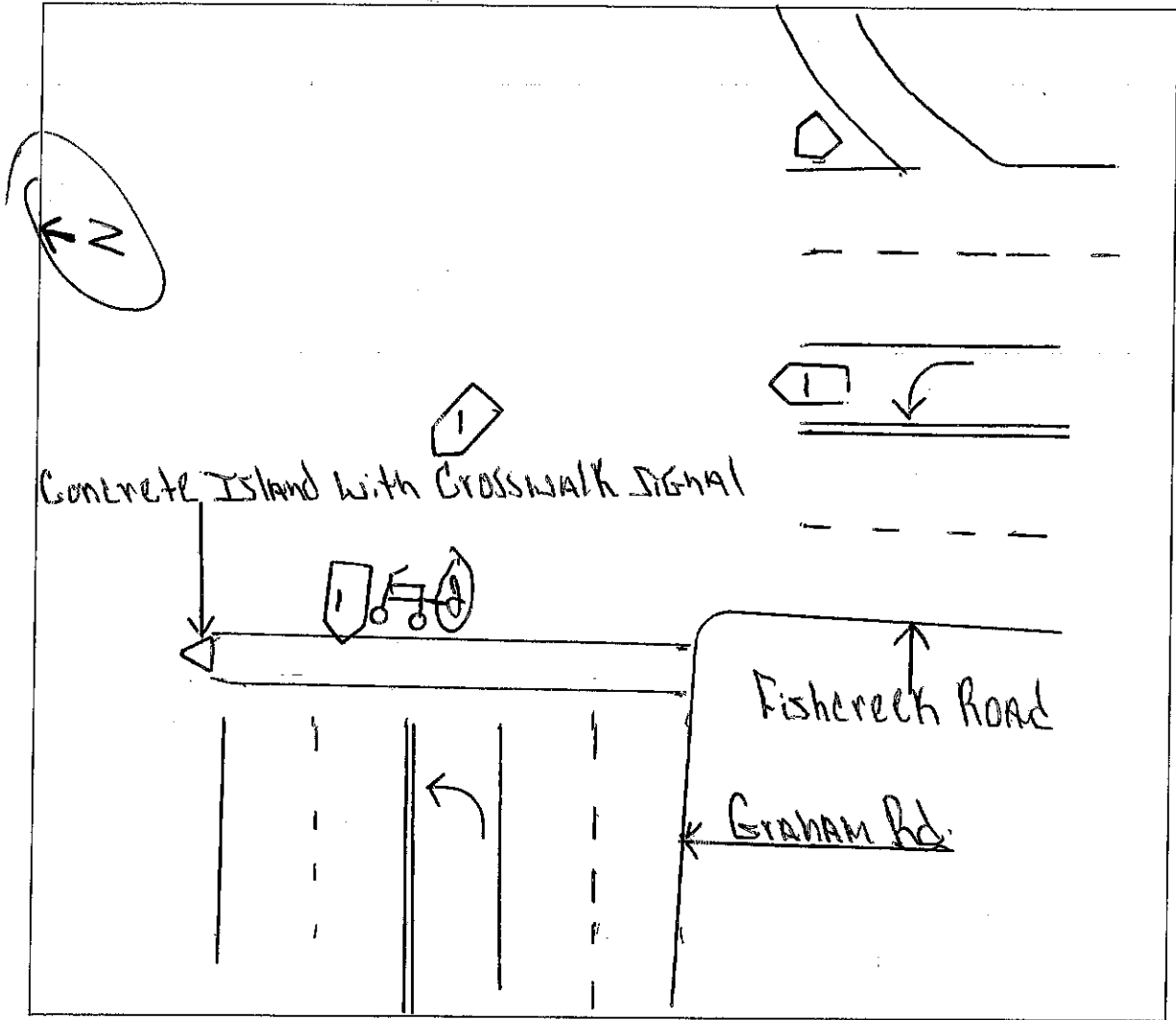

While making the left turn, Driver #1 struck the front tire of Driver #2 (bicyclist). I was stopped at the red traffic signal on Graham Rd. at Fishcreek Rd. and my cruiser camera captured part of the incident. I was unable to see the crosswalk signal. However, when Driver #1 started moving to turn left, all of the other vehicles going northbound started moving at the same time.**

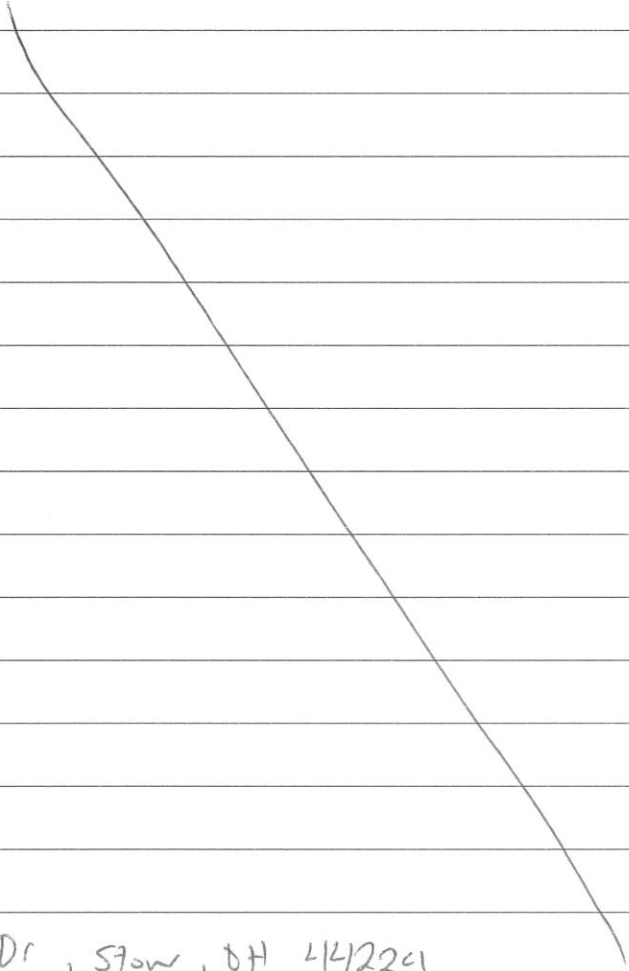
