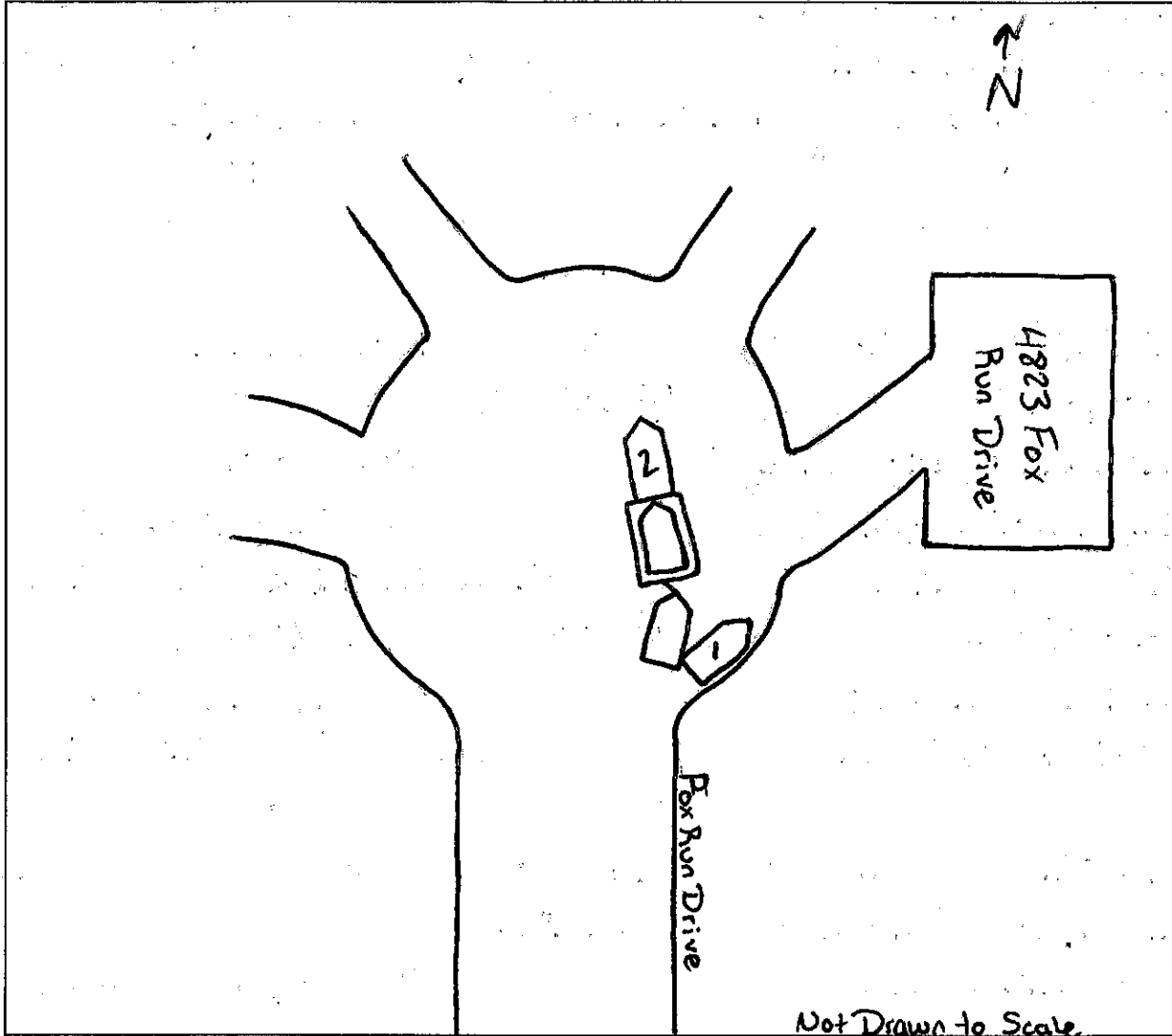

The rear car's (red car's) right side appeared to have scraped against the Volkswagen Beetle's left side which was parked in the cul-de-sac. The tow truck proceeded into another neighbor's driveway to turn around & never got out to look at the Volkswagen & continued driving. Kevin Pataki & Emily Pataki went to look at the left side of the Volkswagen & saw the damage from the tow truck. 
