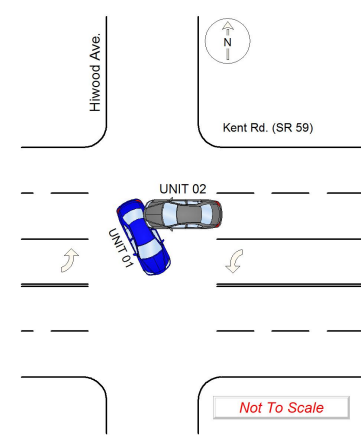
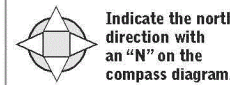

NARRATIVE

Unit 01 was traveling southbound on Hiwood Avenue and began making a left (eastbound) turn through the intersection onto Kent Road (S.R. 59), with a green light. Unit 02 was traveling westbound on Kent Road approaching the intersection of Hiwood Avenue. Unit 02 stated there was a strong glare from the sun making it difficult to see the traffic signal. Unit 02 failed to stop for the red light and struck Unit 01.

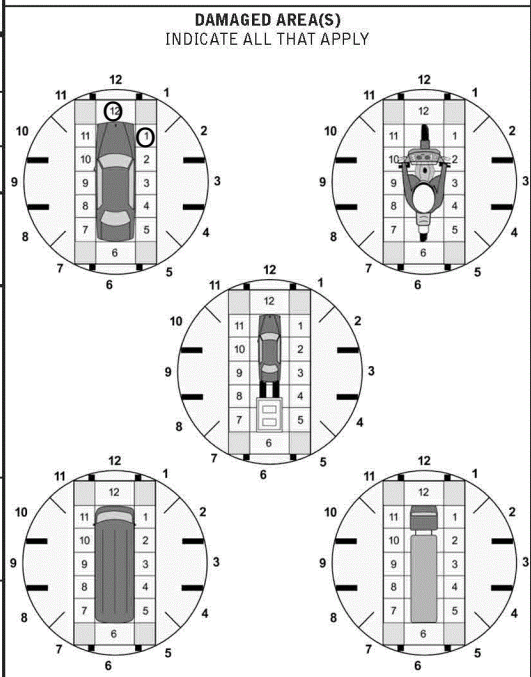
