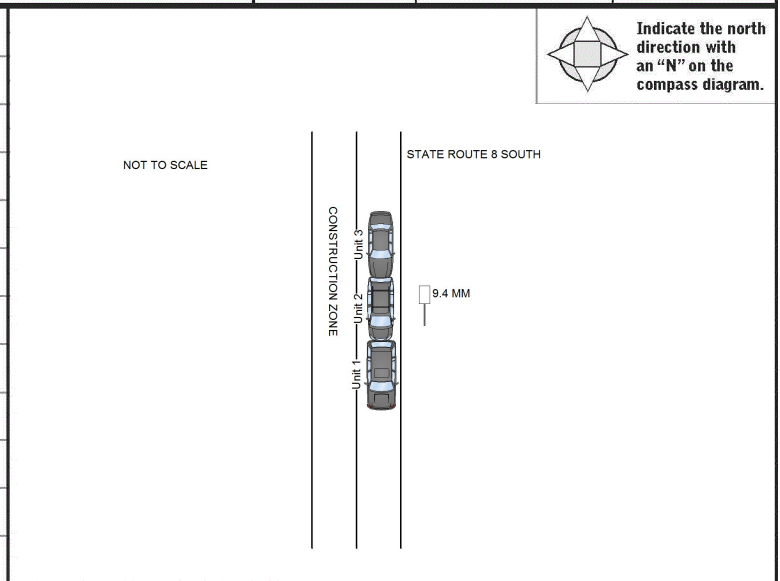

UNIT #1 WAS SOUTHBOUND ON STATE ROUTE 8 IN THE LEFT LANE, SLOWING IN TRAFFIC. UNIT #2 WAS DIRECTLY BEHIND UNIT #1. UNIT #3 WAS DIRECTLY BEHIND UNIT #2. UNIT #3 FAILED TO ASSURE CLEAR DISTANCE AND STRUCK UNIT #2 FROM BEHIND. THIS IMPACT PUSHED UNIT #2 FORWARD AND CAUSED IT TO STRIKE UNIT #1 FROM BEHIND.

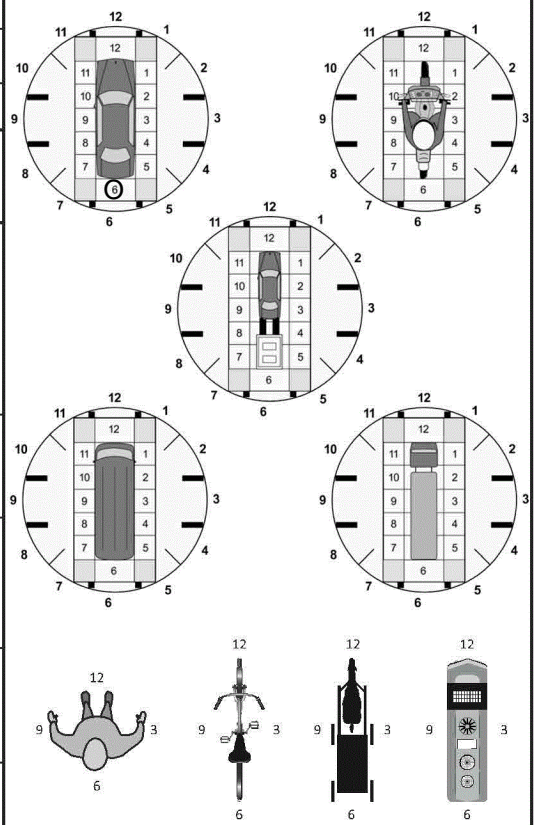


