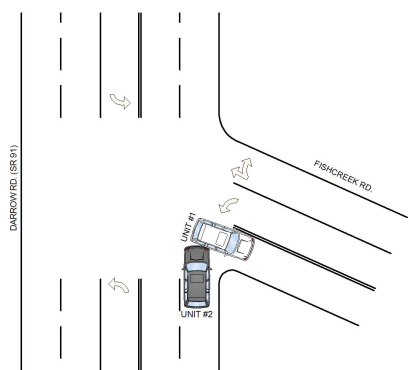

UNIT #1 WAS ATTEMPTING TO MAKE A LEFT TURN FROM STATE ROUTE 91 TO HEAD SOUTHEAST ONTO FISHCREEK RD. UNIT #2 WAS TRAVELING NORTHBOUND ON STATE ROUTE 91 IN THE FAR RIGHT LANE APPROACHING THE FISHCREEK RD. INTERSECTION. ONCE THE LIGHT TURNED RED, UNIT #1 MADE A LEFT TURN TO CLEAR THE INTERSECTION. UNIT #2 FAILED TO STOP AT THE RED LIGHT. AS A RESULT, THE FRONT BUMPER OF UNIT #2 STRUCK THE REAR PASSENGER SIDE
