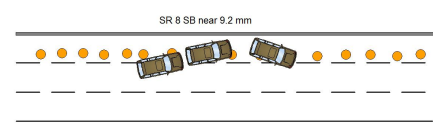

NARRATIVE

Unit 01 was traveling southbound in the left, fast lane.

Unit 01 left the travel lane and struck several traffic barrels, which were blocking off a closed third lane. Unit 01 then overcorrected and struck several more barrels while returning to the original lane of travel. Unit 01 originally left the scene, but was located temporarily disabled, near the 8.6 mile marker. The driver of Unit 01 stated she fell asleep.
