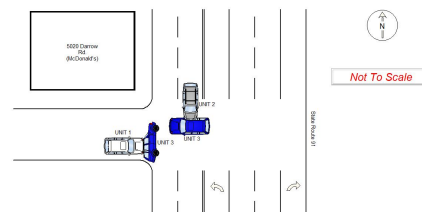
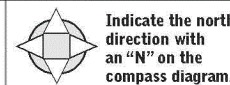

NARRATIVE

Unit 1 was stopped, facing east bound, waiting to turn out of McDonald's parking lot (5020 SR91). Unit 2 was traveling south bound on Darrow Road (SR91), in the inside lane. Unit 3 was traveling north on Darrow Road, in the left turning lane. Unit 3 attempted to turn left into McDonald's (5020 SR91). Unit 3 failed to yield the right of way to Unit 2. Unit 2 struck Unit 3 as a result. Unit 3 then overturned, landing on the driver's side, and striking Unit 1. Unit 3 came to a rest on the driver's side, facing northbound.
