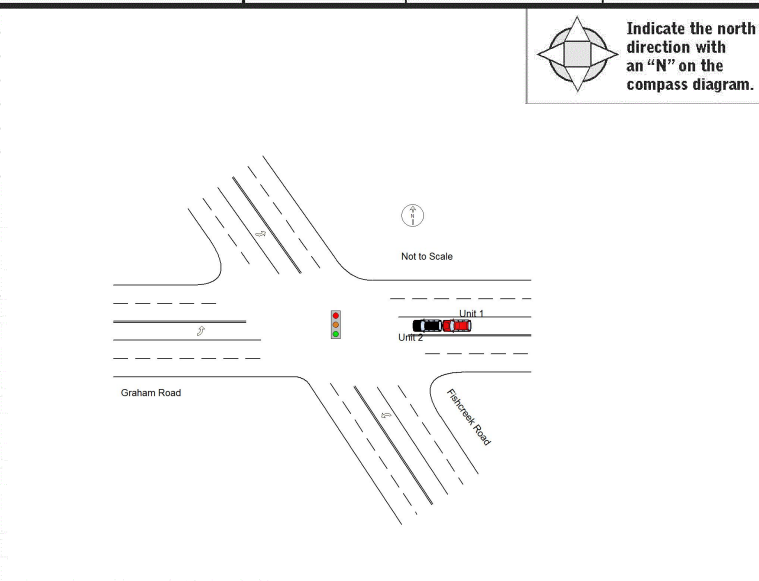

Unit 1 was traveling the same direction and in the same lane as Unit 2. Unit 1 failed to assure cleared distance ahead and struck Unit 2 as a result.**
