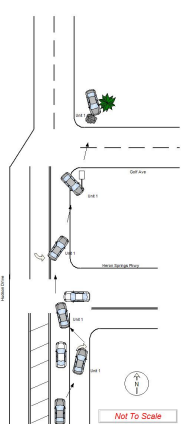

**Unit 1 was traveling north on Hudson Dr. in the 3500 block.**

**Unit 1 attempted to pass a vehicle on the right. The right lane is a right turn only lane. As Unit 1 was attempting to pass, a vehicle pulled out of a drive on Hudson Dr. Unit 1 swerved and lost control of the vehicle. Unit 1 continued north, out of control, and struck a street sign. The vehicle continued north, but was now facing southbound, and struck a rock in the yard of 3629 Hudson Dr. Unit 1 dislodged the rock from the ground and pushed the rock north. Unit 1 came to a rest atop the rock.**

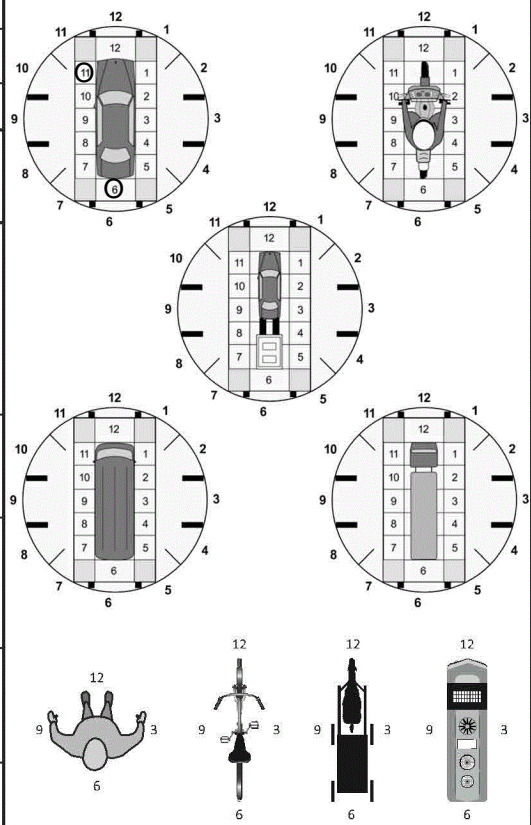
