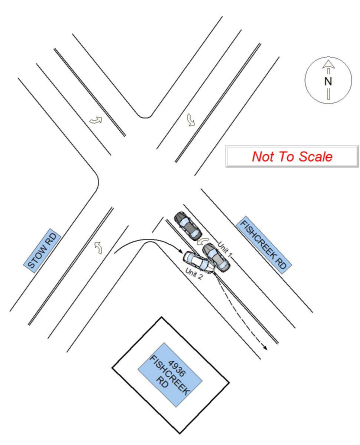

UNIT 1 WAS STOPPED IN TRAFFIC AT THE INTERSECTION OF FISHCREEK ROAD AND STOW ROAD FACING NORTHBOUND IN THE LEFT TURN LANE. UNIT 2 WAS TURNING SOUTHBOUND ONTO FISHCREEK ROAD FROM STOW ROAD, CROSSED OVER THE DOUBLE YELLOW LINE AND STRUCK UNIT 1. UNIT 2 FLED THE SCENE OF THE CRASH.
