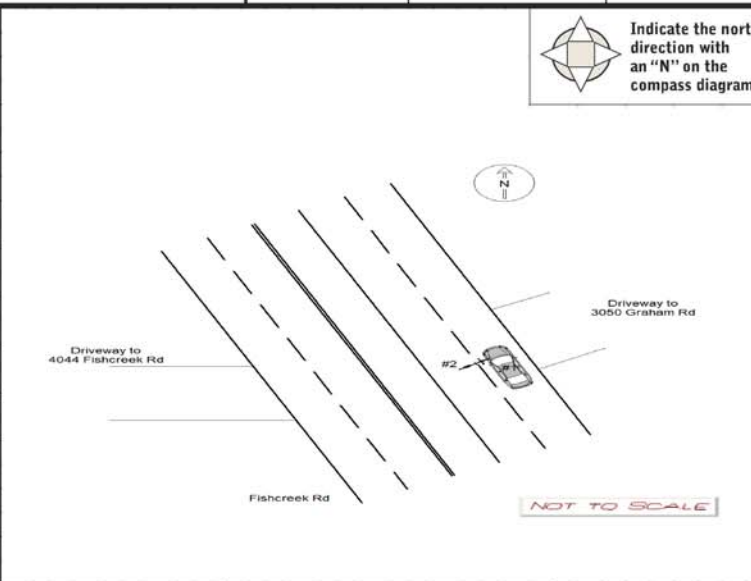

Unit #1 was northbound on Fishcreek Rd in the curb lane approaching Graham Rd. Unit #2, a bicyclist, was crossing Fishcreek Rd from the west to the east beginning at 4044 Fishcreek RD. Unit #2 rode eastbound through a line of cars in the northbound left straight-through lane and failed to yield the right of way to Unit #1 in the curb lane. Unit #2 struck the driver's side of Unit #1.

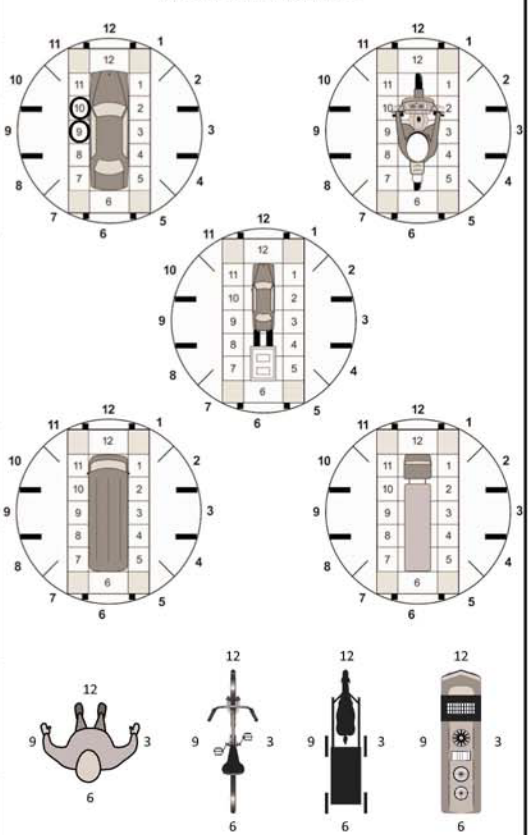

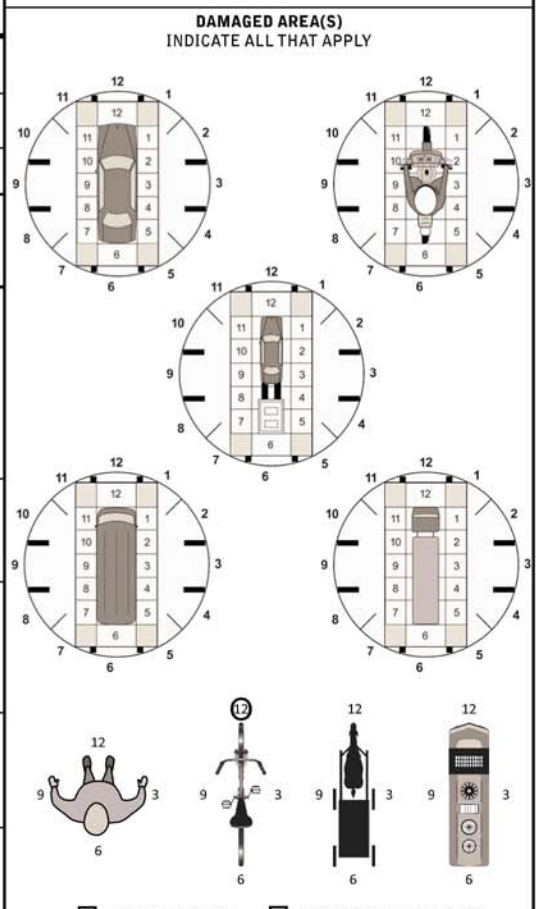
