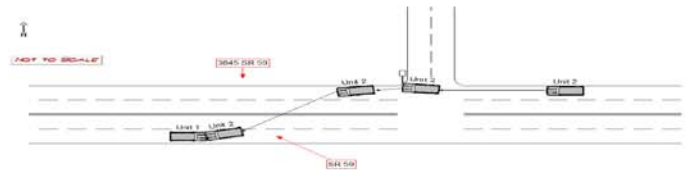
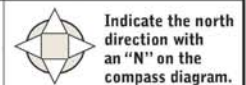

UNIT 1 WAS EASTBOUND ON SR 59 IN THE CURB LANE IN FRONT OF 3854. UNIT 2 WAS WESTBOUND IN THE CURB LANE, TRAVEL LED ACROSS FOUR LANES OF TRAFFIC, AND STUCK UNIT 1 HEAD-ON. THE DRIVER OF UNIT 2 WAS BELIEVED TO BE HAVING A SEIZURE AND WAS EXHIBITING POST SEIZER SYMPTOMS.

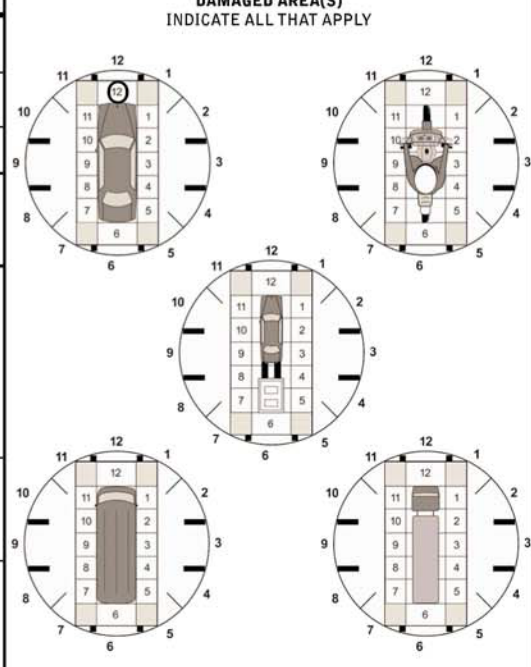

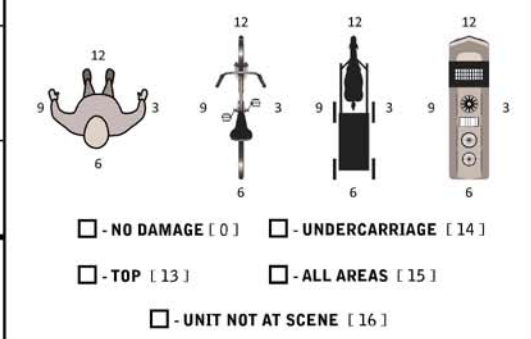
