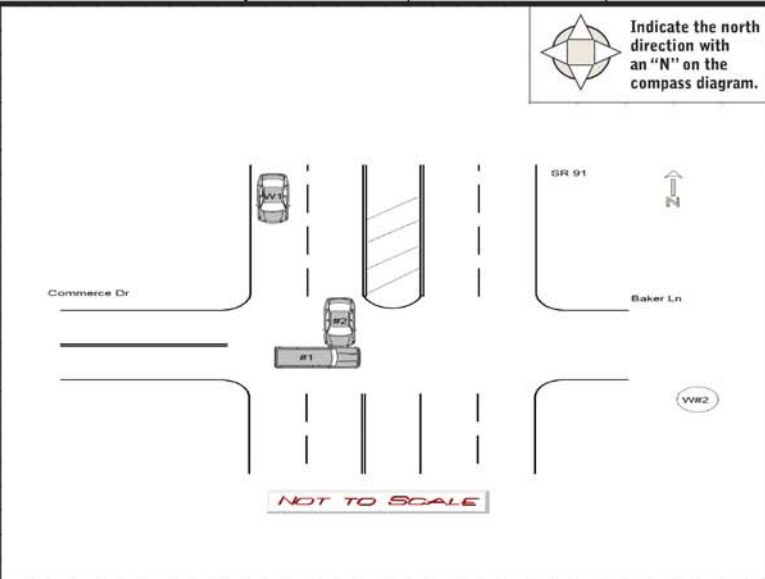

**Unit #1 was traveling eastbound on Commerce Dr approaching SR 91 (Darrow Rd). Unit #1 had the green light and entered the intersection with the intentions of turning left (north) onto SR 91. Unit #2 was southbound on SR 91 in the inside lane. Unit #2 ran the red light and struck the front left of Unit #1. There were two witnesses who observed this accident. The first was southbound on SR 91 and the second was a pedestrian standing in his driveway on Baker Ln.**

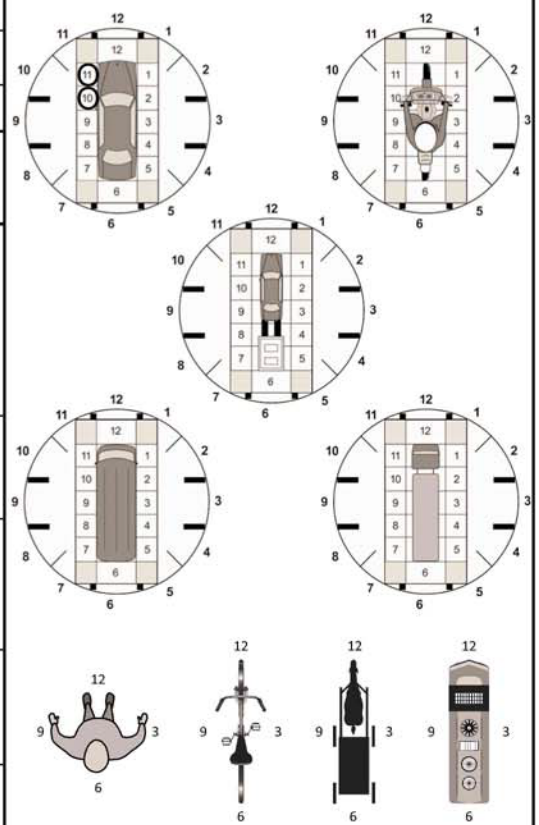

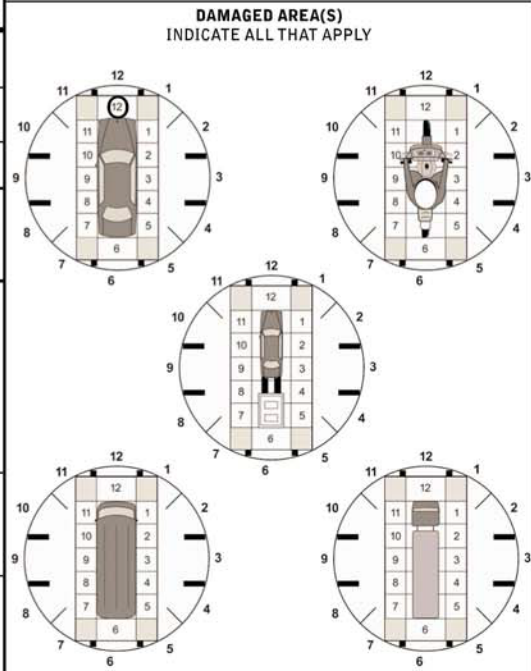

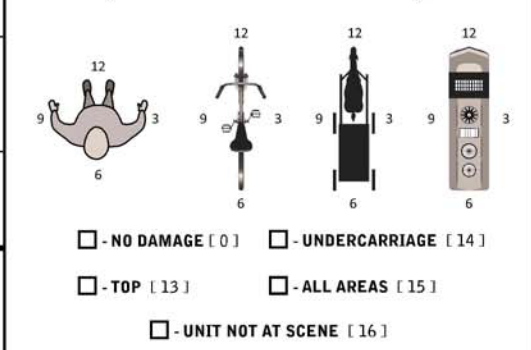
