**She was traveling northbound on Hudson Drive. Unit # 1 entered the East-Most turn lane to make a left (westbound) turn into Walmart plaza. Unit # 2 was in the west-most left turn lane, directly to the west of Unit # 1. Both Units proceeded with the turn and Unit # 2 failed to maintain their lane, striking Unit # 1.**

**Unit # 2 Stated they were in the west-most lane to make a left (westbound) turn into Walmart Plaza when she was struck by Unit # 1. She did not know where Unit # 1 came from.**

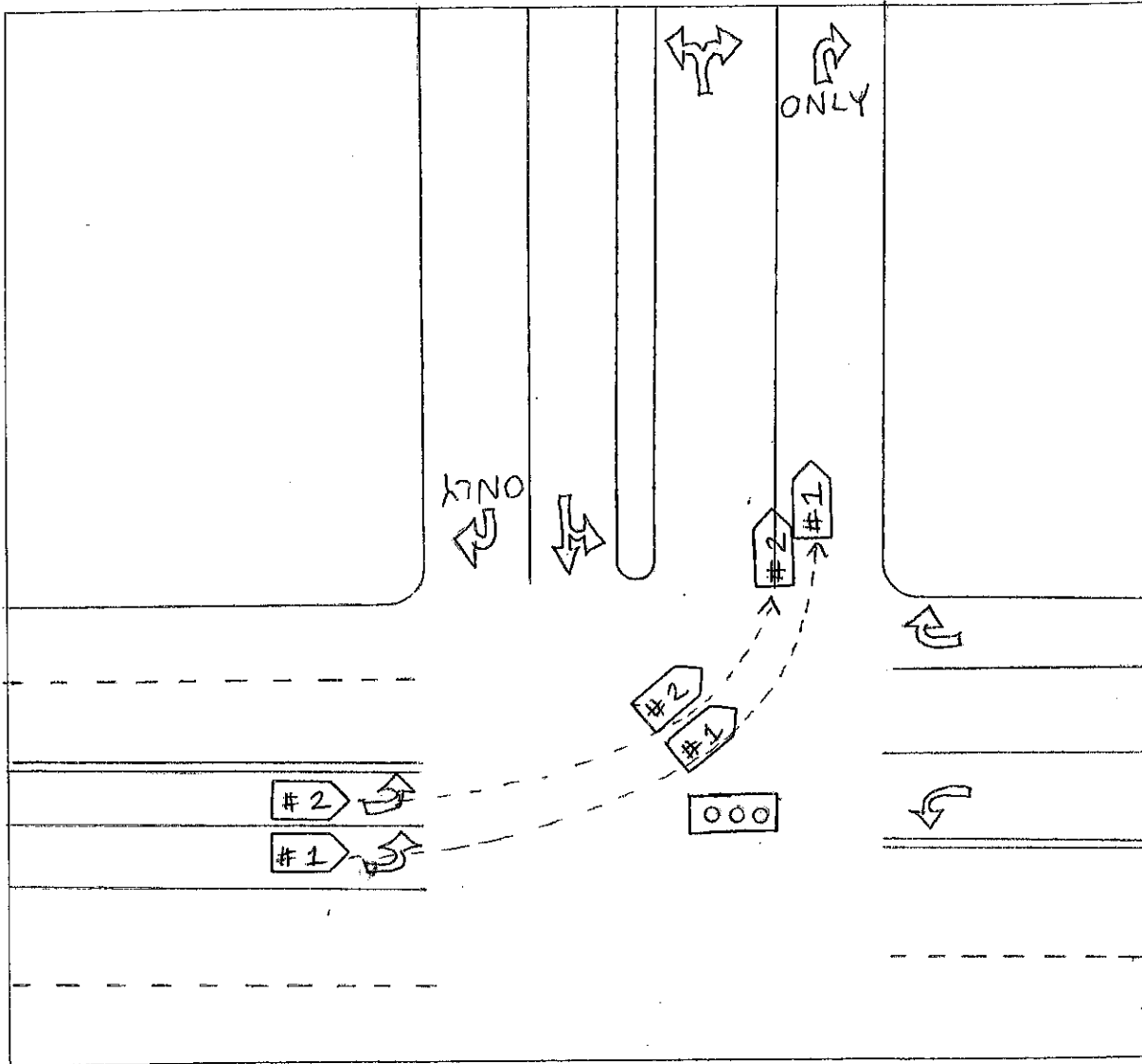
