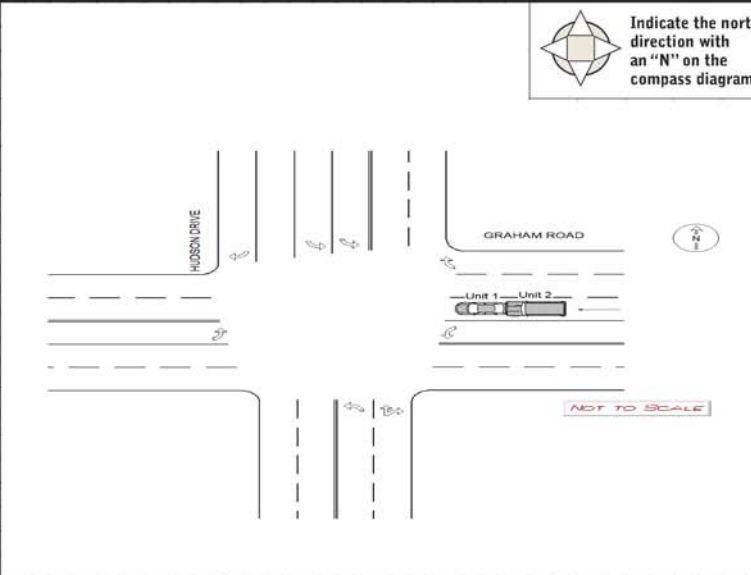

UNIT 1 WAS WESTBOUND IN THE LEFT THROUGH LANE ON GRAHAM ROAD AT THE INTERSECTION OF HUDSON DRIVE. UNIT 1 WAS STOPPED AT A RED LIGHT. UNIT 2 WAS BEHIND UNIT 1 HEADING THE SAME DIRECTION. UNIT 2 FAILED TO STOP AND MAINTAIN DISTANCE FROM UNIT 1, RESULTING IN UNIT 2 STRIKING UNIT 1.

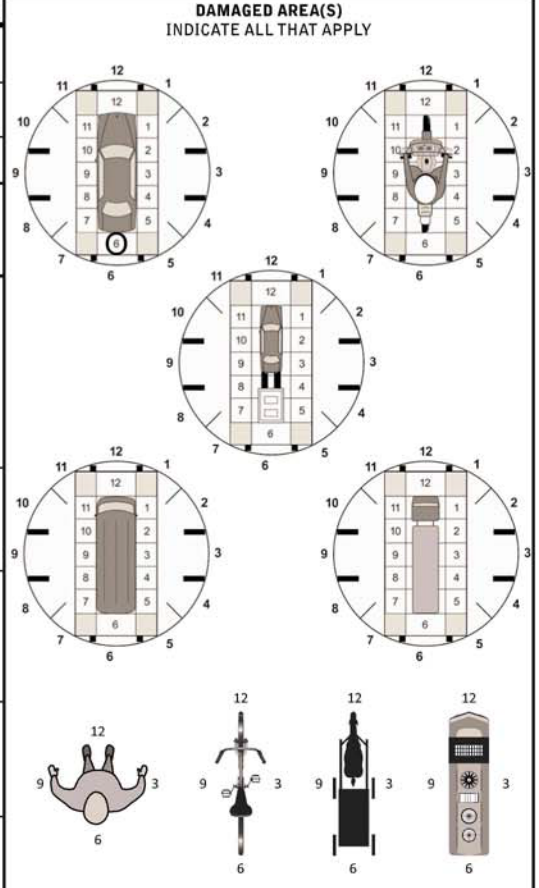

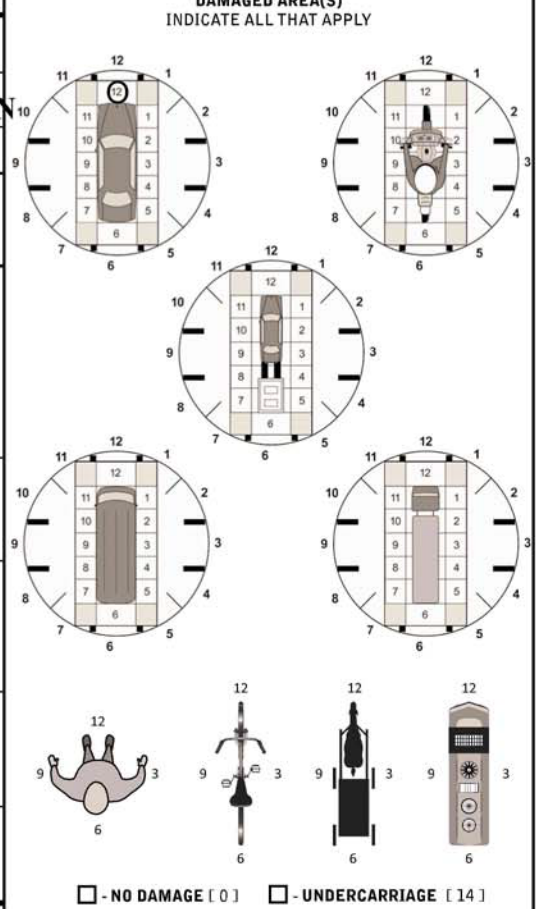
