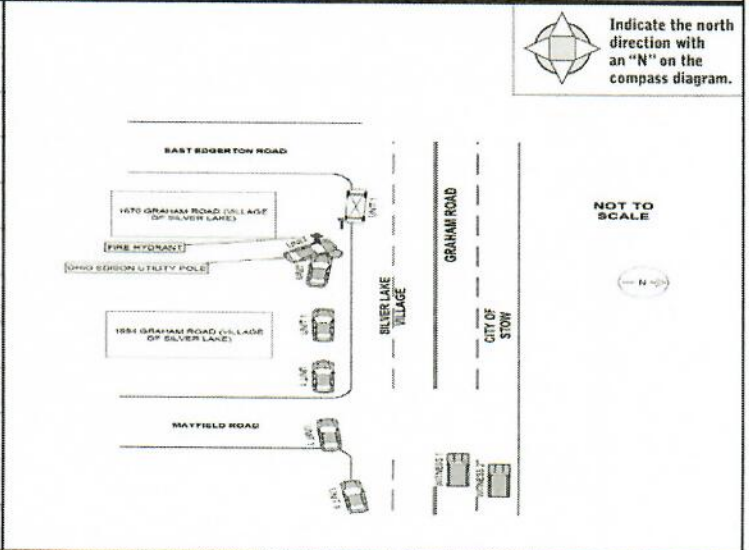

WITNESSES WERE WB ON GRAHAM RD WHEN UNIT 1, ALSO WB, WENT LEFT OF CENTER ATTEMPTING TO PASS WITNESS #1. UNIT 1 STRUCK A CURB NEAR MAYFIELD ROAD AND CONTINUED TO LEAVE THE ROADWAY ONTO PRIVATE PROPERTY. UNIT 1 THEN STRUCK A UTILITY POLE AND FIRE HYDRANT AT 1684 GRAHAM ROAD WHICH CAUSED UNIT 1 TO OVERTURN AND COME TO REST WHILE STRIKING A MAILBOX AT 1670 GRAHAM ROAD.

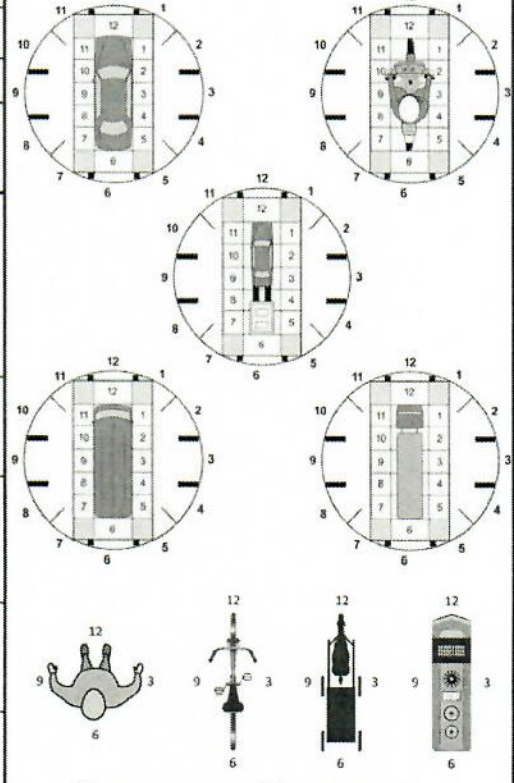
