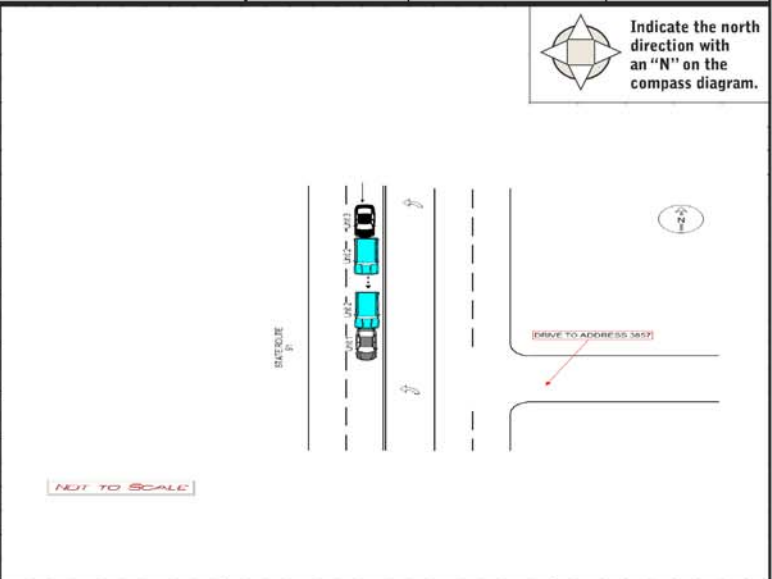

UNIT 1 AND 2 STOPPED IN TRAFFIC NEAR ADDRESS 3857. UNIT 3 FAILED TO ASSURE CLEAR DISTANCE, RESULTING IN UNIT 3 STRIKING UNIT 2. THE IMPACT OF UNIT 3 HITTING UNIT 2, CAUSED UNIT 2 TO STRIKE UNIT 1.

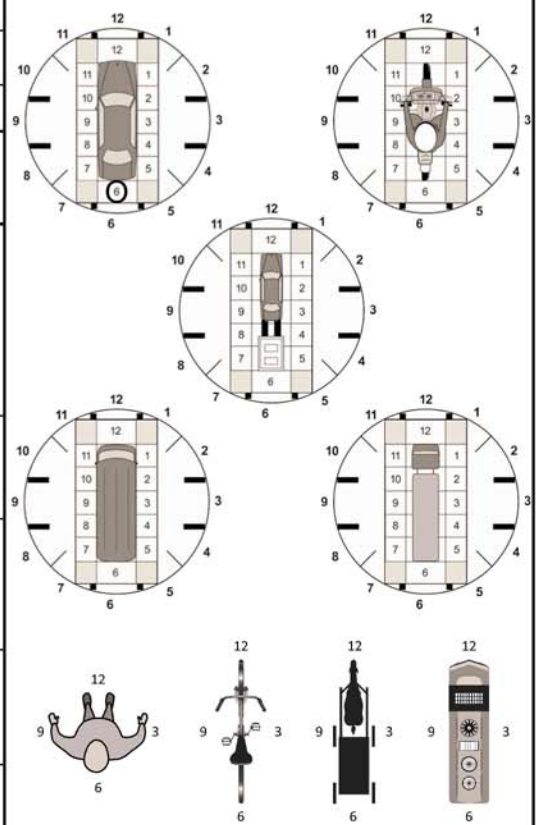

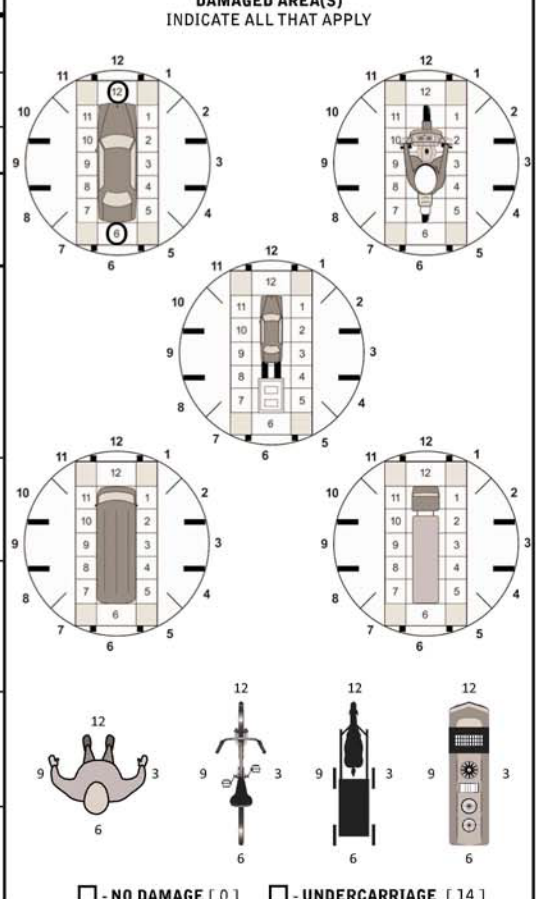
