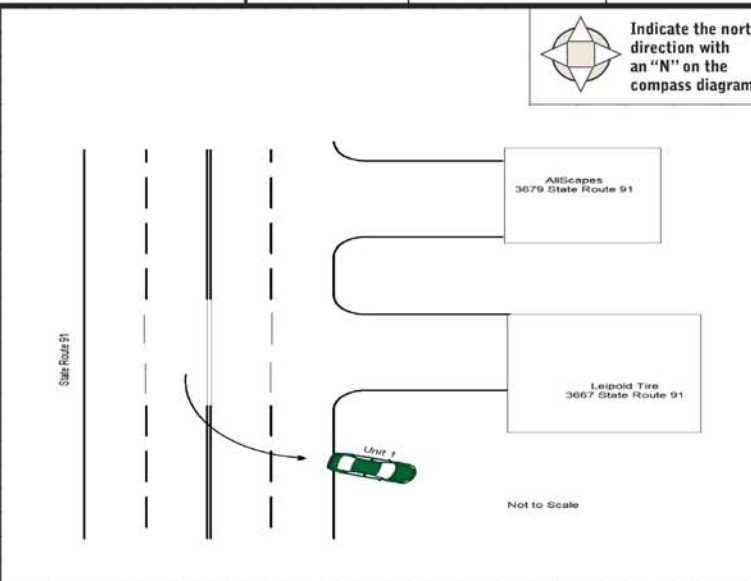

NARRATIVE
Unit #1 was driving a vehicle with a flat tire from their residence to get the tire replaced at Leipold Tire. Unit #1 was northbound on State Route 91. Unit #1 missed the turn into Leipold Tire and turned into AllScapes. The driver turned around and turned southbound on State Route 91. Unit #1 then attempted a left turn (eastbound) into Leipold Tire. Unit #1 missed the entrance by several feet, striking the curb, and finally came to a stop after crossing the sidewalk. Only one tire remained on the roadway.

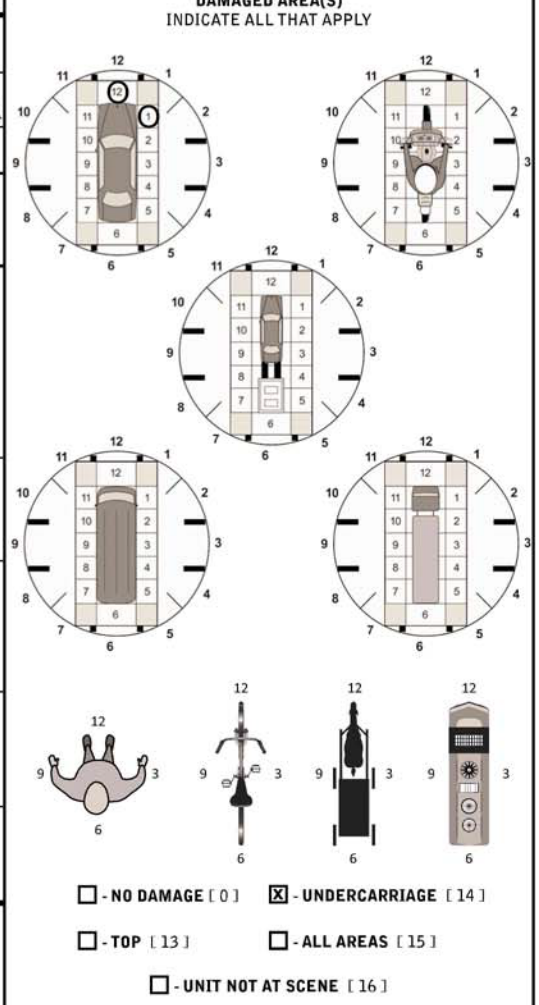
