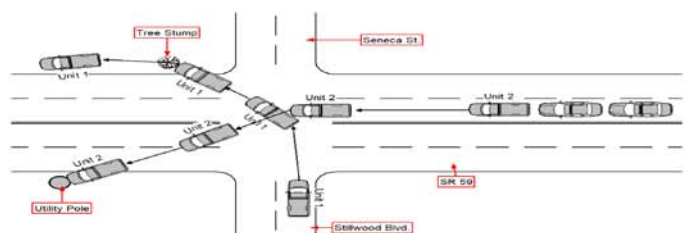
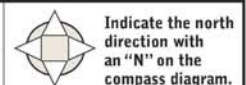

NARRATIVE

Kent PD was pursuing unit 2 (a stolen truck) from their city, westbound on Kent Rd. The vehicle at times was traveling at excess of 80MPH, was swerving, and driving left of center. As the vehicle approached Stillwood Blvd it was traveling at approximately 55-65MPH. Unit 1 was making a turn to go westbound on Kent Rd from Stillwood Blvd. Due to the excessive speeds and reckless driving, unit 2 struck unit 1. Unit 1 then ran off the roadway to the right and struck a tree stump. Unit 2 ran off the road to the left and struck a utility pole. The

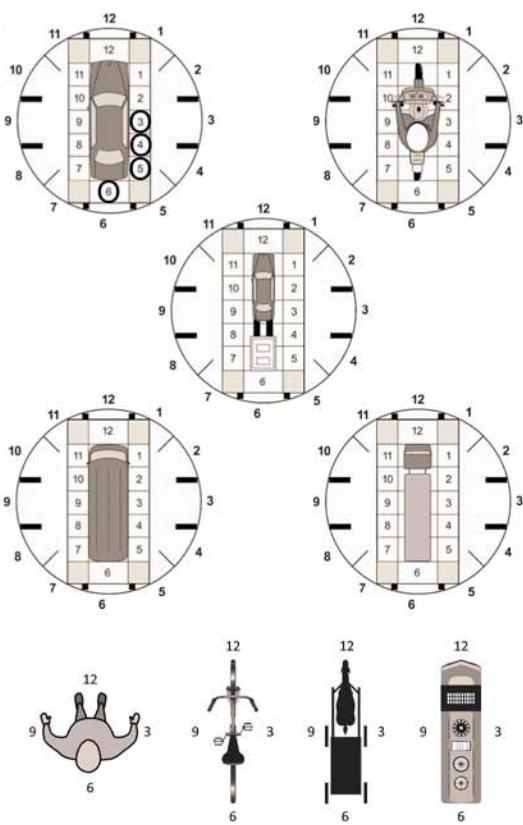

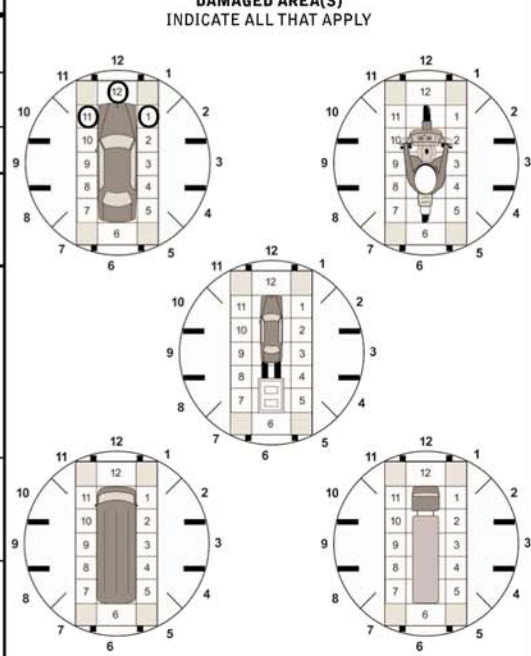

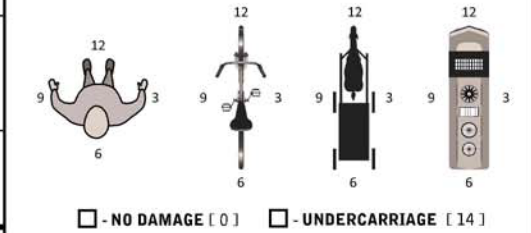
