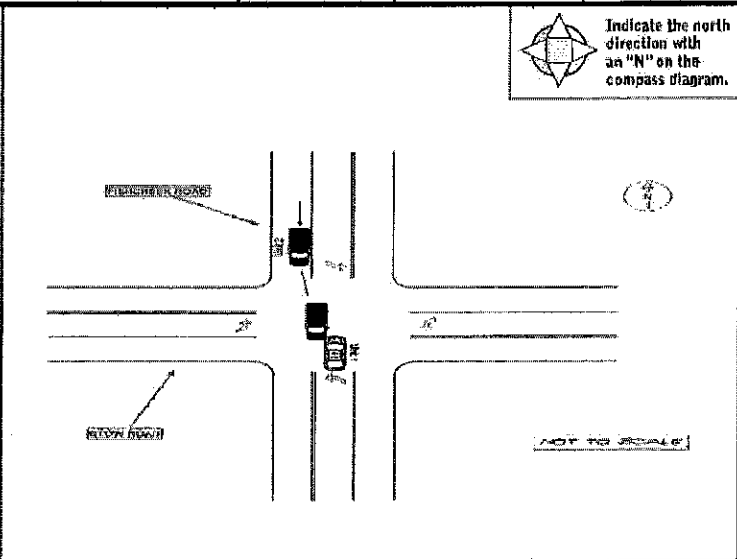

UNIT 2 WAS HEADED SOUTHBOUND ON FISHCREEK ROAD. UNIT 2 WENT LEFT OF CENTER WHILE CROSSING THE INTERSECTION OF STOW AND FISHCREEK ROAD, RESULTING IN UNIT 2 STRIKING UNIT 1.

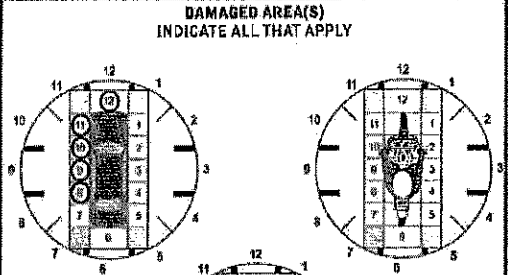

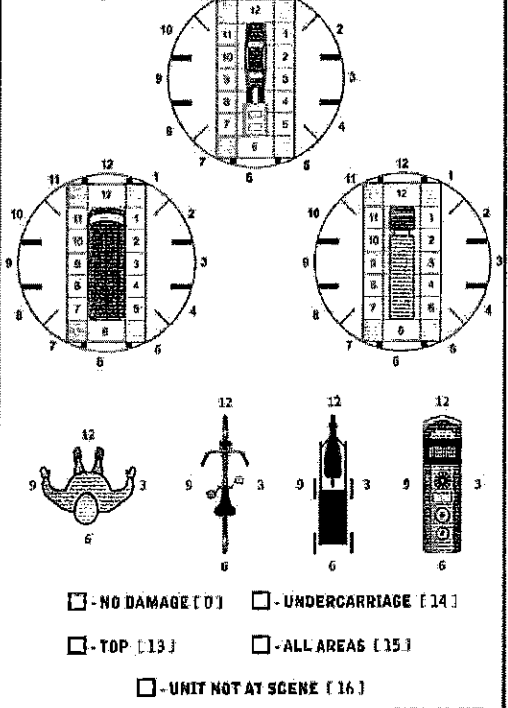

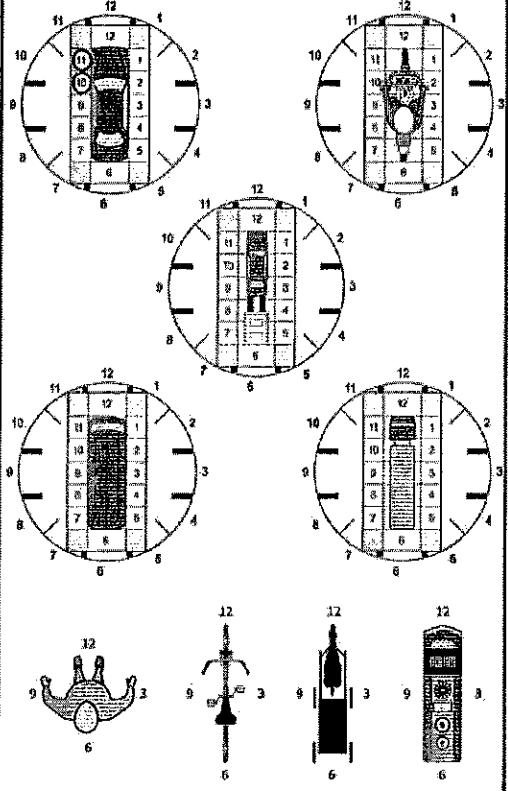
