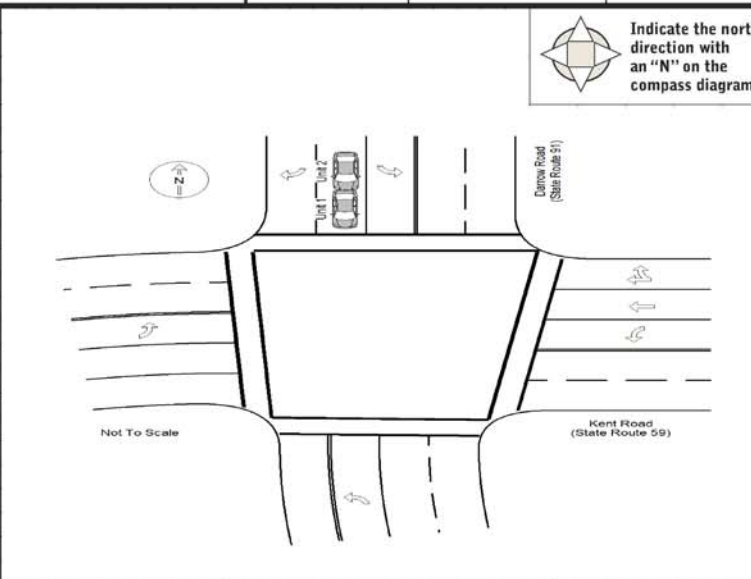

UNIT 1 WAS SOUTH ON SR 91 IN THE MIDDLE LANE STOPPED AT THE SR 59 TRAFFIC SIGNAL. UNIT 2 WAS BEHIND UNIT 1. THE DRIVER OF UNIT 2 THOUGHT THE LIGHT HAD TURNED GREEN AND BEGAN TO ACCELERATE BEFORE UNIT 1, CAUSING UNIT 2 TO STRIKE UNIT 1.
