Unit 1 attempted to change lanes after the turn, causing unit 1 to strike unit 2.**

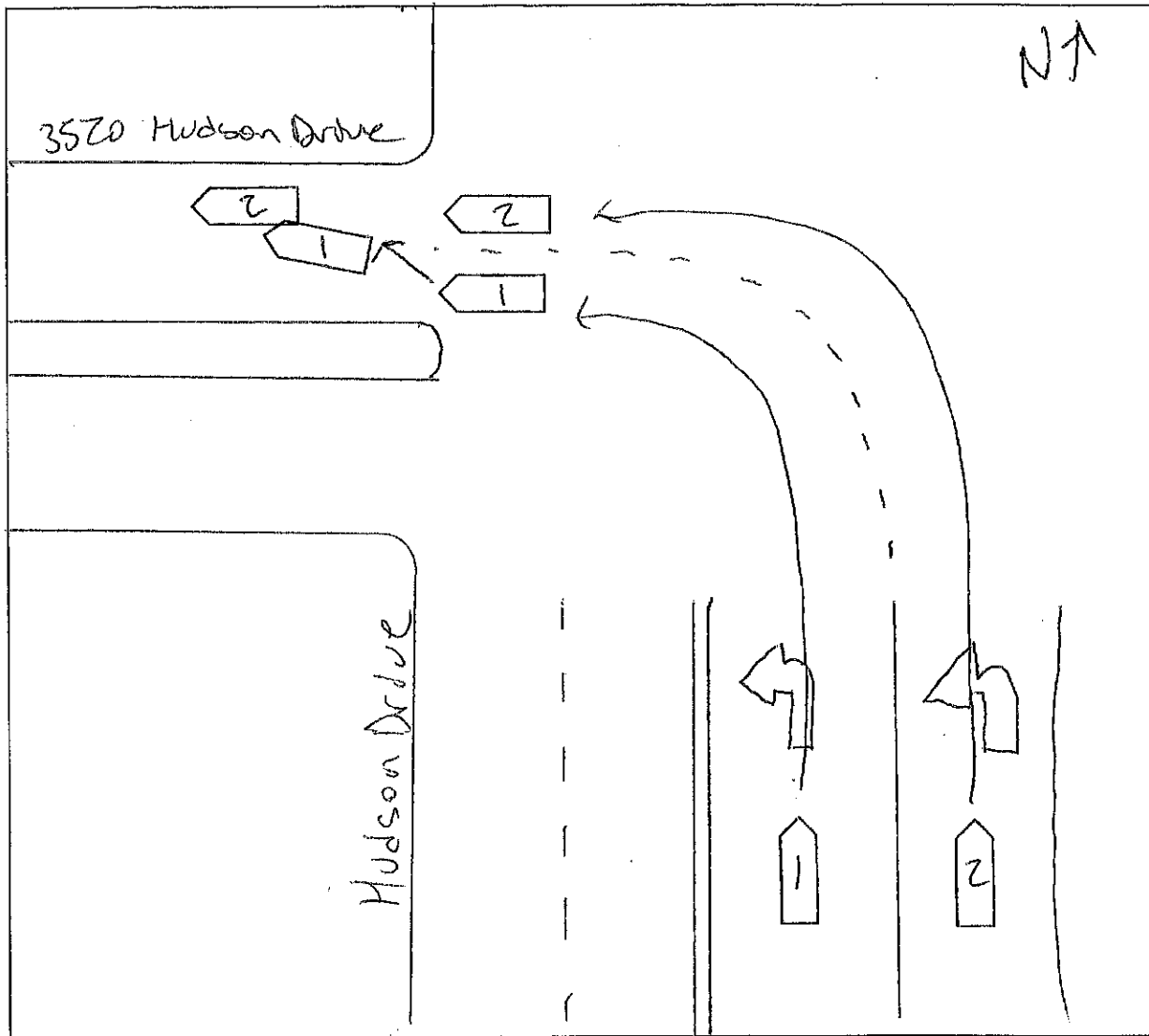
