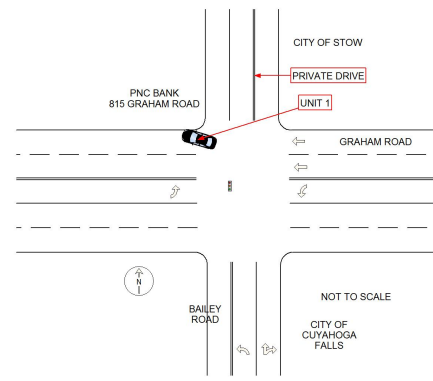
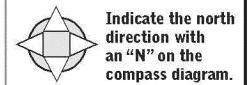

UNIT 1 HAD BEEN NB ON BAILEY ROAD AND NEEDED TO TURN LEFT (WB) ONTO GRAHAM ROAD. UNIT 1 MADE THE LEFT TURN AT A HIGH RATE OF SPEED AND STRUCK A CURB AFTER FAILING TO SAFELY MAKE THE TURN. THE CRASH WAS CAUGHT ON A LOCAL VIDEO SURVEILLANCE CAMERA.

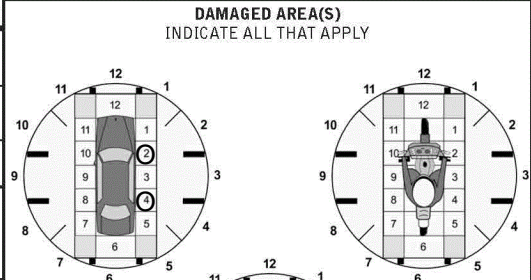

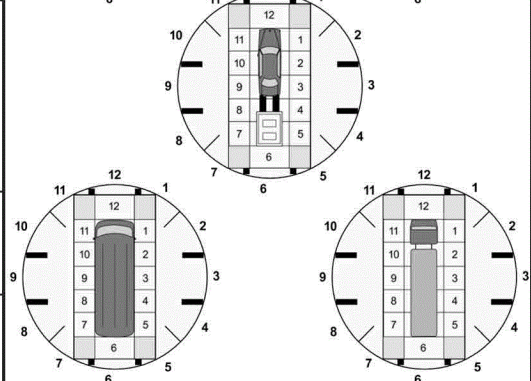

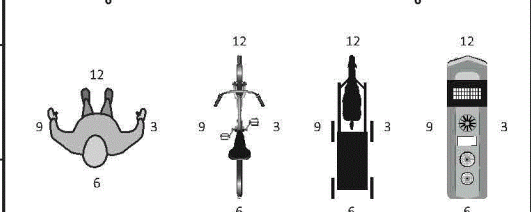

At this point, she became entirely irate and out of line towards me. She started cursing at me, fellow police officers and wished me to have a really bad day. This conversation was recorded on my BWC.

I issued Jones a citation for Failure to Control and turned the crash in.
