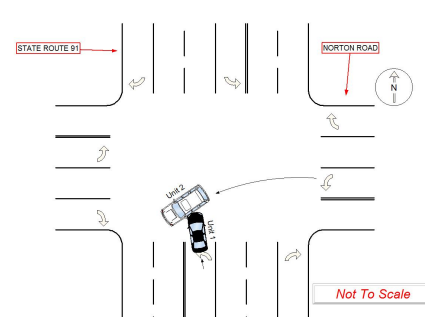
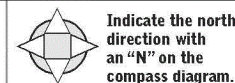

UNIT 2 STATED THEY ENTERED THE INTERSECTION WHEN THE LIGHT WAS YELLOW, AND TURNED LEFT. UNIT 1 STATED THEY HAD THE GREEN ARROW AND BEGAN ENTERING THE INTERSECTION. THE VEHICLES COLLIDED IN THE INTERSECTION.

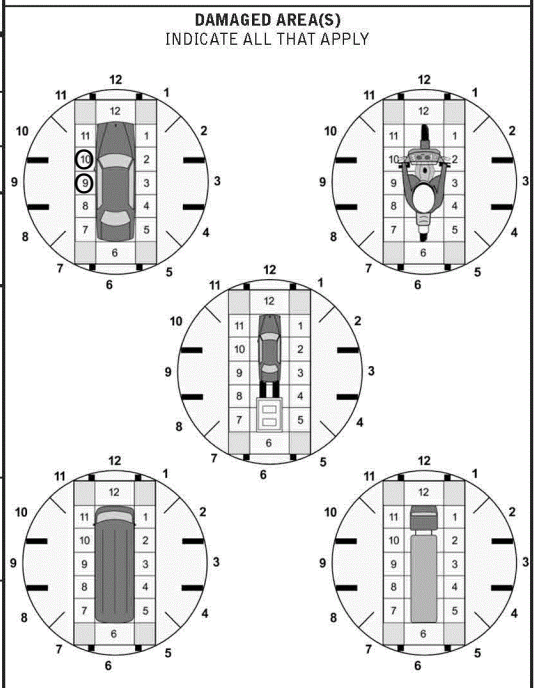

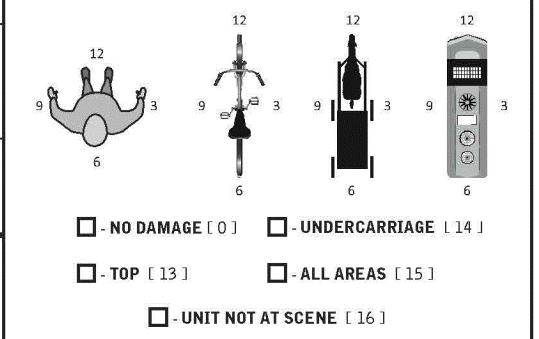
