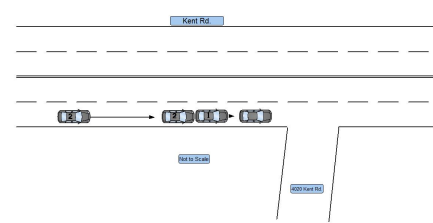
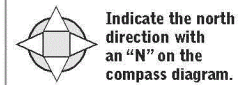

Unit #2 failed to maintain assured clear distance and struck unit #1 causing damage to both vehicles. When Unit #1 was struck by Unit #2, it was pushed into another vehicle in front of it. The driver of that vehicle stopped, and did not wish to be included in this report. That vehicle was gone upon police arrival. No injuries were reported.

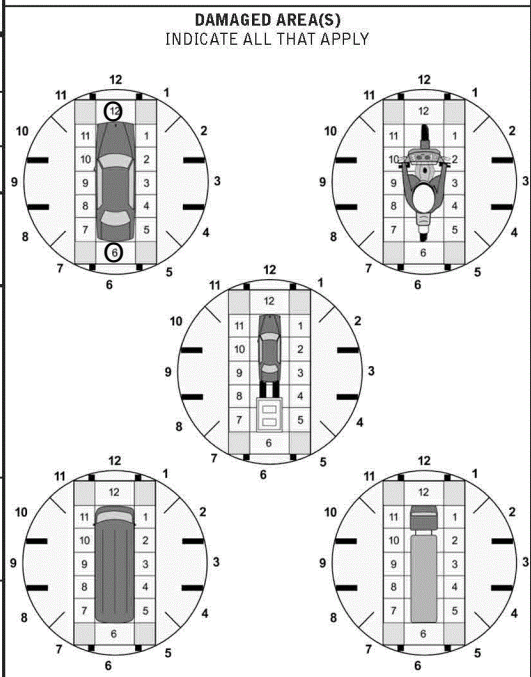

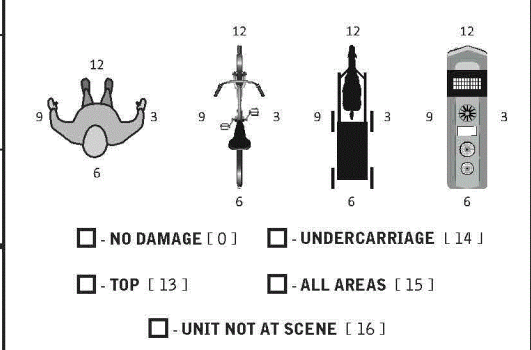
