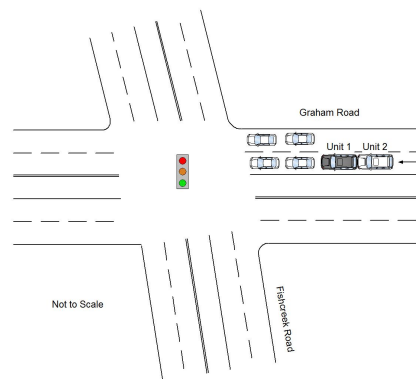
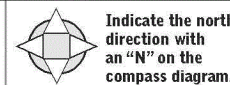

Both drivers declined making a written statement.
