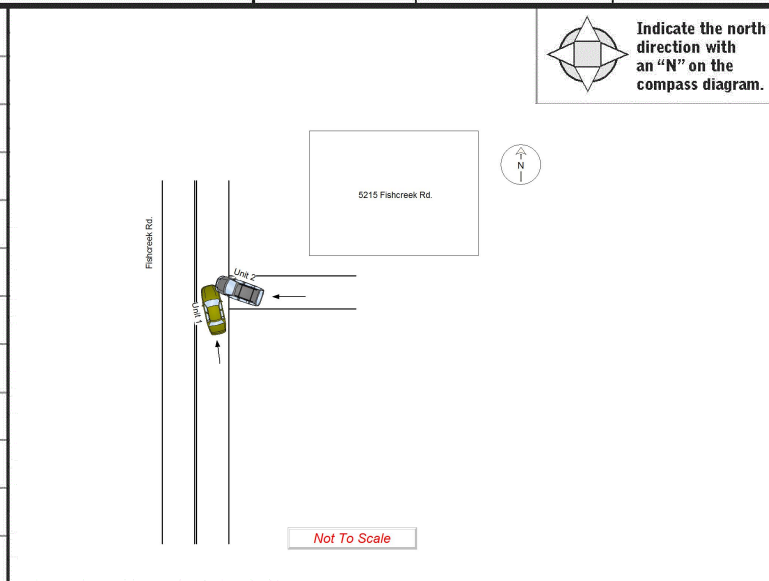

Unit 1 was traveling north on Fishcreek Rd. approaching 5215 Fishcreek Rd. Unit 2 was attempting to exit the driveway of 5215 Fishcreek Rd. from east to north. Unit 2 failed to yield to the right of way of Unit 1 exiting the driveway and striking Unit 1 on the passenger side. Unit 2 then failed to stop after the accident and was later located by officers.

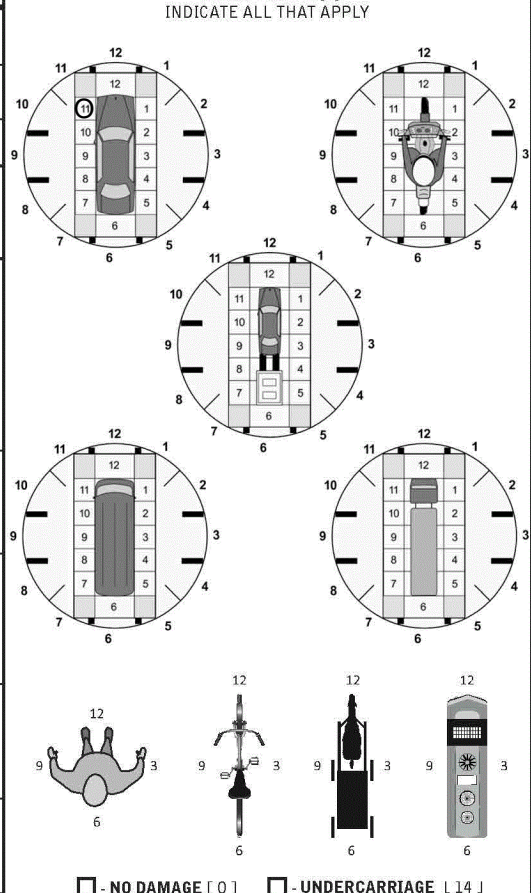
