Veh#2, a truck pulling a black 2018 car hauling trailer (TRV4948), was eastbound on Steels Corners Rd and began to turn right (south) onto Hudson Dr. Veh#1 was eastbound on Steels Corners Rd in the right straight-thru lane to continue onto Hudson Dr (north). As Veh#1 pulled along the left of Veh#2's trailer, the rear left of the trailer pivoted into Veh#1's lane. The rear left of the trailer struck the right side of Veh#1.

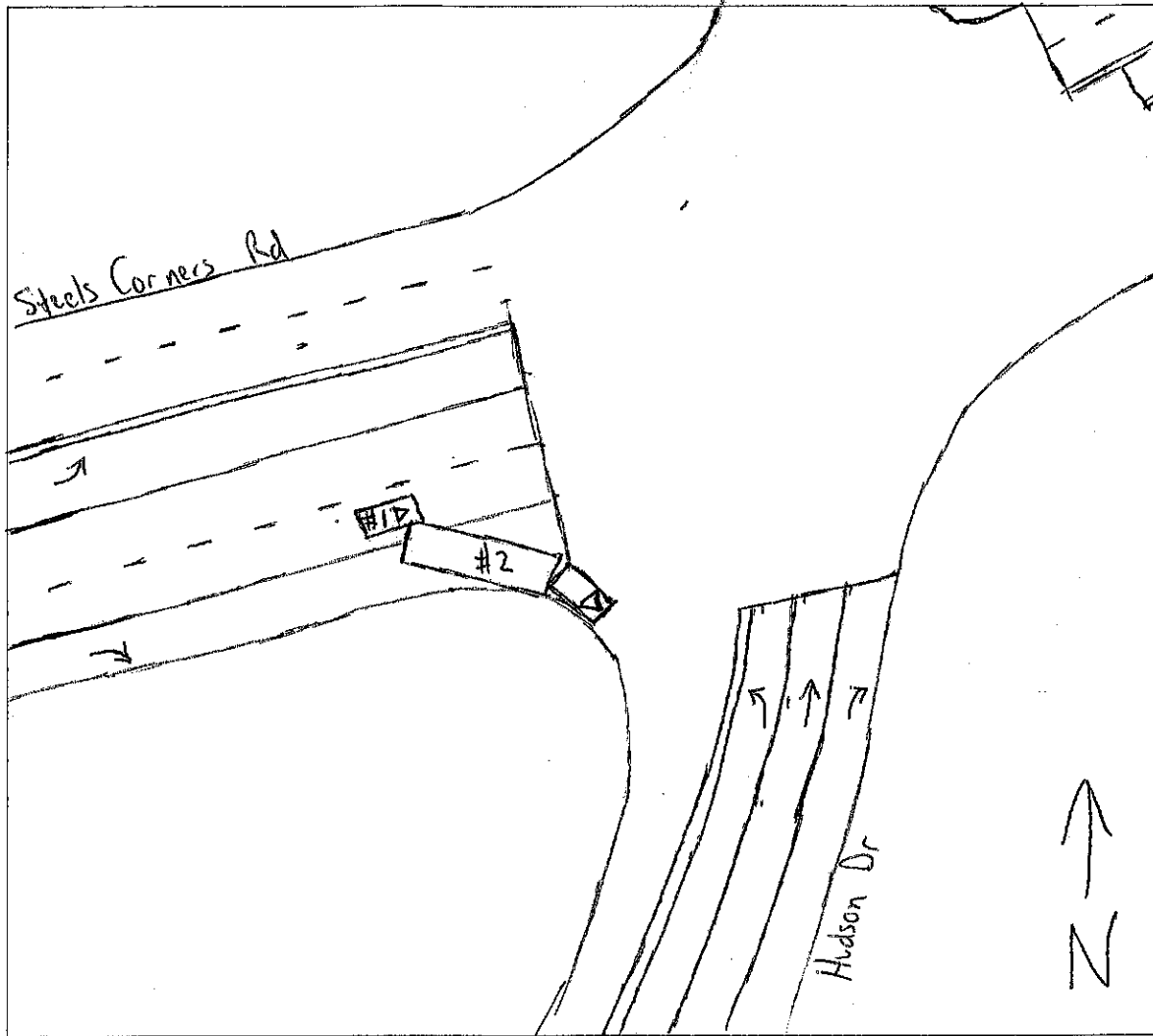
