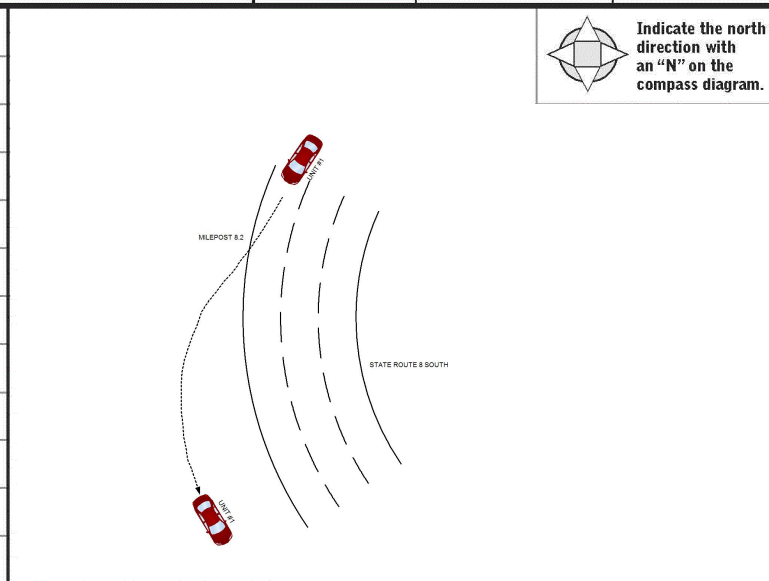

UNIT #1 WAS TRAVELING SOUTHBOUND ON STATE ROUTE 8 SOUTH NEAR THE 8.2 MILEPOST. UNIT #1 FAILED TO CONTROL AND DROVE OFF OF THE RIGHT SIDE OF THE ROADWAY. THE FRONT END OF UNIT #1 THEN STRUCK A SNOW EMBANKMENT, CAUSING IT TO BECOME DISABLED.
