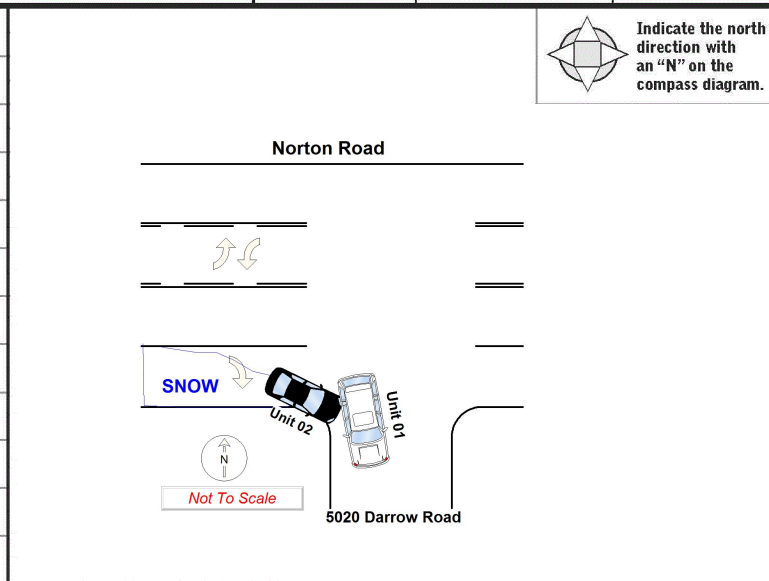

NARRATIVE

Unit 01 was traveling eastbound on Norton Road and made a right (southbound) turn into Mcdonald's (5020 Darrow Road). Unit 02 was directly behind Unit 01 and made the same turn into Mcdonald's. Unit 01 stated Unit 02 rear-ended him. Unit 02 stated he was in the right turn lane and Unit 01 was in the middle lane. Unit 02 stated Unit 01 turned in front of him. Snow in the roadway was blocking half of the right turn lane. Due to conflicting statements, the at-fault driver was unable to be determined.

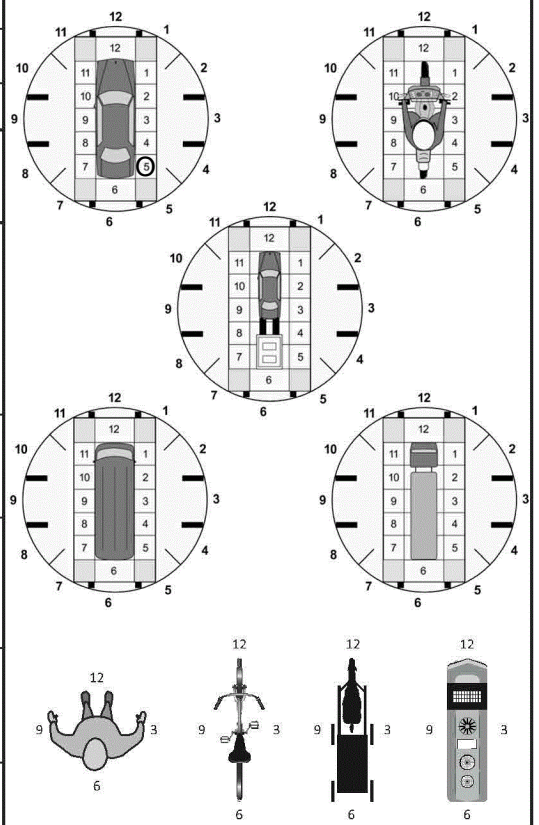

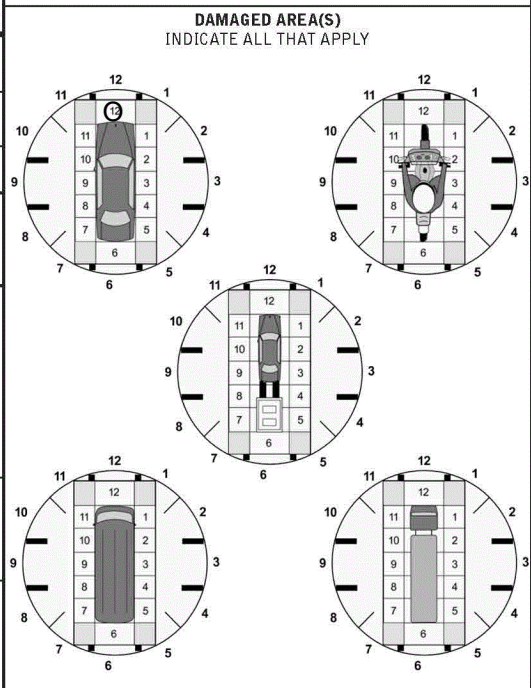

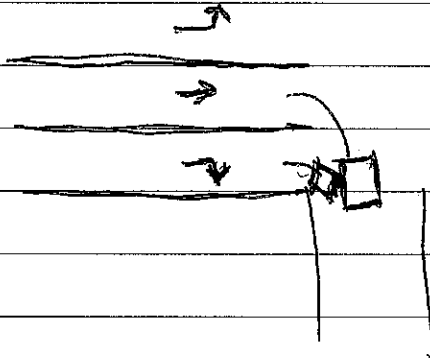
