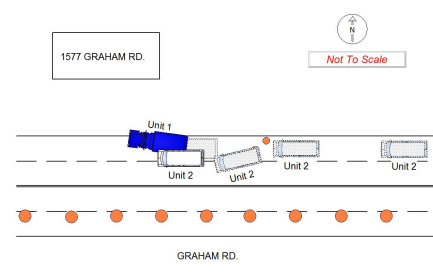

NARRATIVE  
**Both curb lanes in the 1500 block of Graham Rd. were closed for a construction project. Unit #1 was parked in the westbound curb lane. Three traffic cones were set up as a safety zone behind unit #1. Unit #2 was westbound in the curb lane of Graham Rd. Unit #2 stated he was checking his phone. Unit #2 failed to maintain assured clear distance ahead and struck the traffic cones, then struck unit #1. The impact moved unit #1 and pushed it partially onto the curb. Unit #2 declined to be medically evaluated for minor injuries to his hand.**
