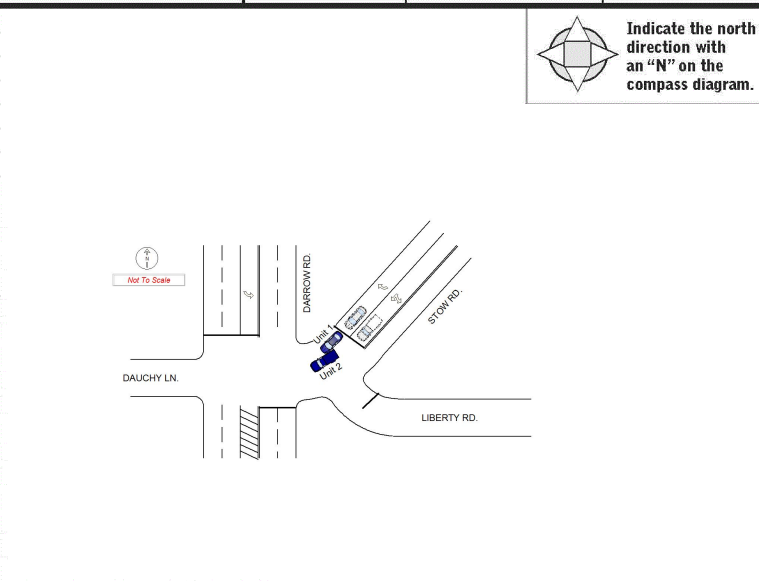

NARRATIVE
Both units were southbound on Stow Rd. at the Darrow Rd. red light. Unit #1 was in the right lane, unit #2 was in the left lane. When the light turned green, unit #1 proceeded to make a right turn (north) onto Darrow Rd. and unit #2 proceeded to make a left turn (south) unto Darrow Rd. Units #1 and #2 collided with each other while making their respective turns. Both parties gave conflicting statements. Both vehicles had moved from the point of impact. Evidence on scene did not indicate which party was at fault. There were no independent witnesses. Police were unable to determine fault.

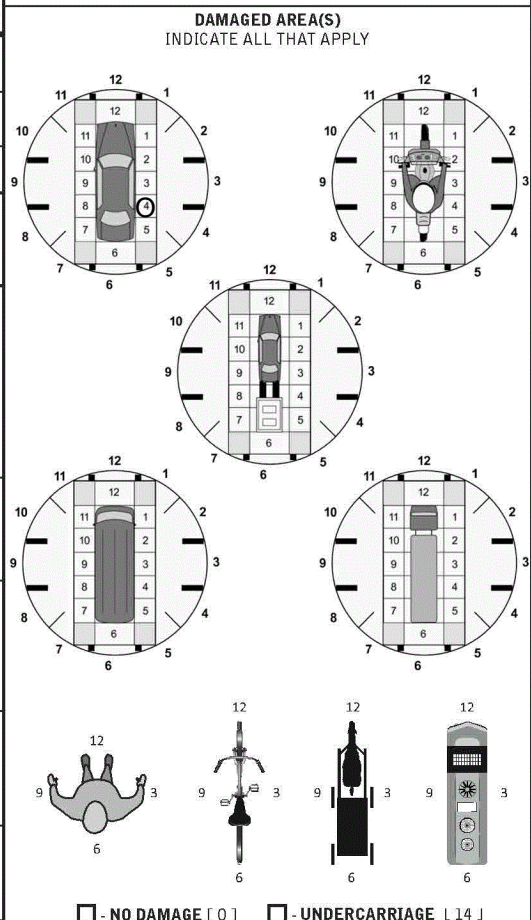

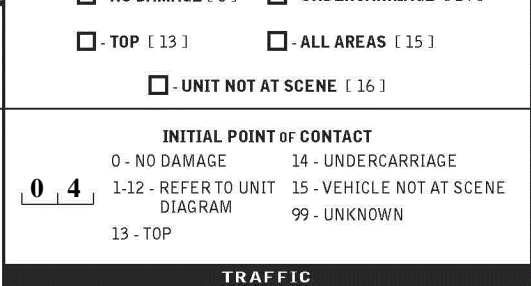
