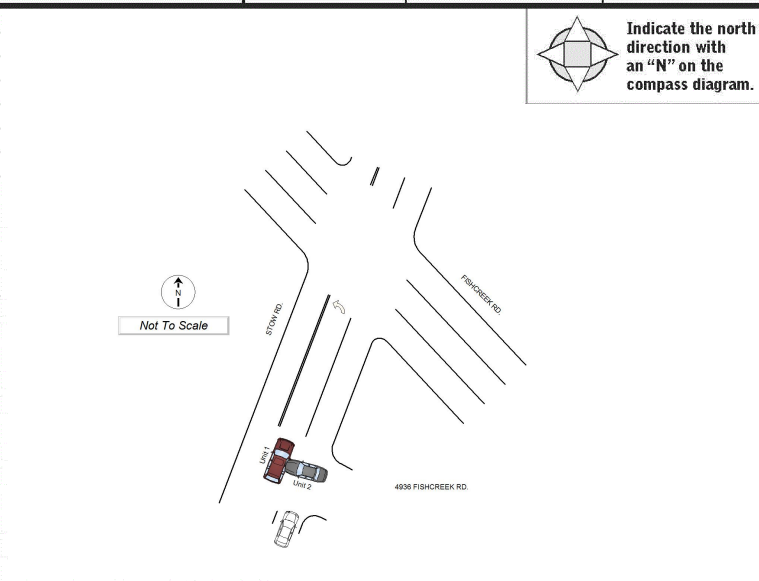

UNIT #2 WAS AT 4936 FISHCREEK RD.

WAITING TO EXIT THE PRIVATE DRIVE THERE TO HEAD SOUTH ON STOW RD. AN UNINVOLVED VEHICLE HEADING NORTHBOUND IN THE CURB LANE STOPPED AT THE DRIVEWAY TO ALLOW UNIT #2 TO TURN OUT OF THE DRIVE. UNIT #2 MADE THE TURN UNKNOWING THAT UNIT #1 WAS TRAVELING NORTHBOUND IN THE LEFT TURN LANE ON STOW RD. APPROACHING THE FISHCREEK INTERSECTION. THE VEHICLES COLLIDED.


