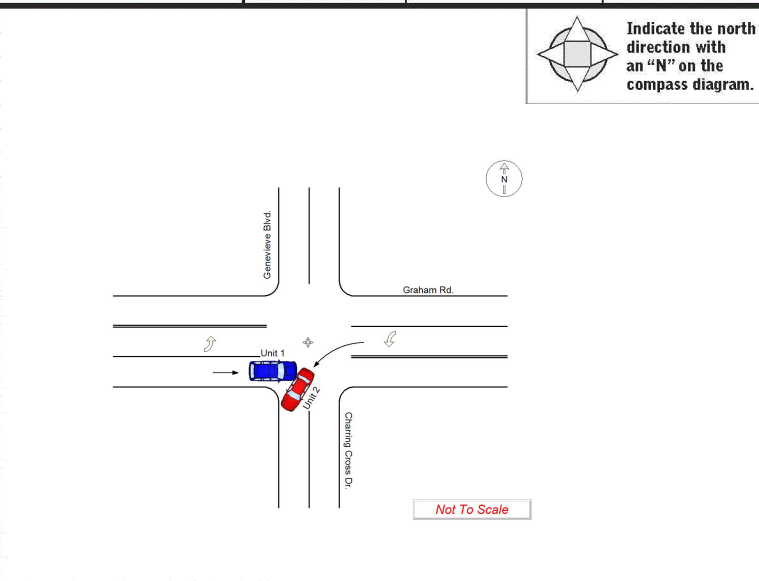

Unit 1 was traveling east on Graham Rd. approaching the traffic signal at Charring Cross Dr. Unit 2 was stopped in the intersection facing west attempting to make a left turn to travel south on Charring Cross Dr. The traffic signal turned yellow as the vehicle in front of Unit 1 entered the intersection. As Unit 1 entered the intersection, Unit 2 made a left turn in front of Unit 1 failing to yield to approaching traffic. Unit 1 struck Unit 2.
