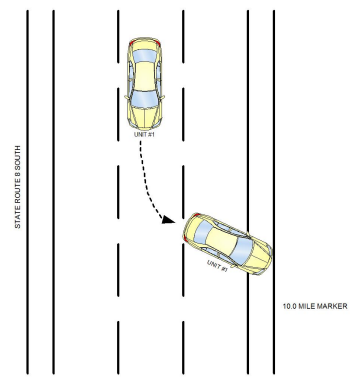

NARRATIVE

UNIT #1 WAS TRAVELING SOUTHBOUND ON STATE ROUTE 8 IN THE MIDDLE LANE NEAR THE 10.0 MILE MARKER. UNIT #1'S FRONT-LEFT TIRE BLEW OUT, CAUSING THE DRIVER TO LOSE CONTROL OF THE VEHICLE. AS A RESULT, UNIT #1 RAN OFF OF THE LEFT SIDE OF THE ROADWAY, AND THE FRONT END OF UNIT #1 STRUCK THE CONCRETE MEDIAN BARRIER. THE DRIVER OF UNIT #1 STATES THE VEHICLE IS NOT CURRENTLY INSURED.

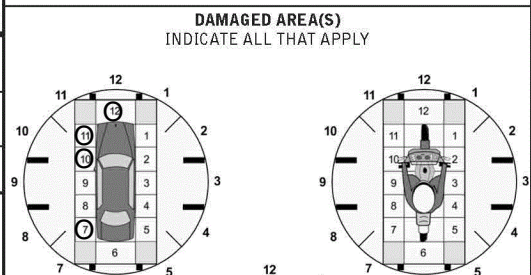

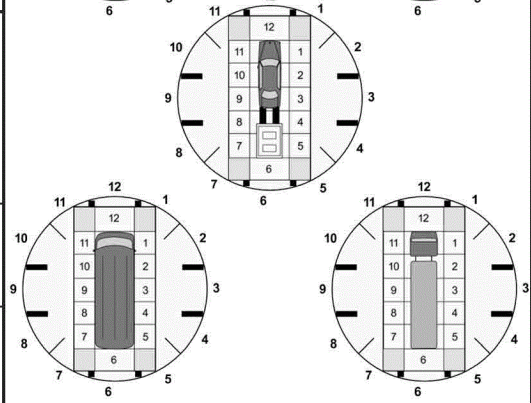

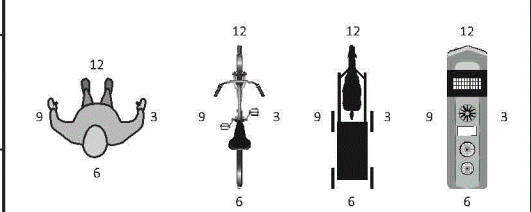
