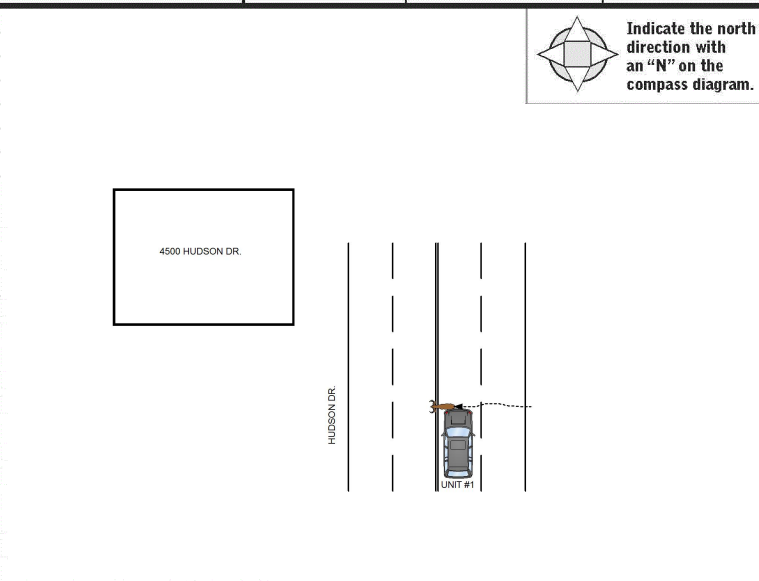

UNIT #1 WAS TRAVELING NORTHBOUND ON HUDSON DR. IN THE LEFT LANE NEAR 4500 HUDSON DR. A DEER RUNNING WESTBOUND ACROSS HUDSON DR. RAN OUT IN FRONT OF OF UNIT #1. AS A RESULT, THE DEER STRUCK THE FRONT DRIVER SIDE OF UNIT #1, CAUSING DISABLING DAMAGE TO UNIT #1.
