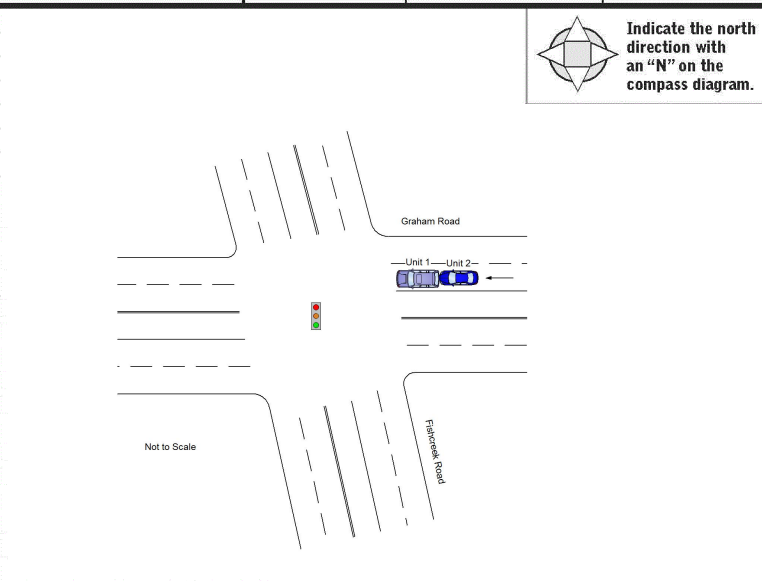

NARRATIVE

Unit #1 was westbound on Graham Road, stopped at the red light at Fishcreek Road. Unit #2 was stopped directly behind Unit #1. Both vehicles were going to proceed straight when they got a green light. The left turn arrow turned green, and Unit #1 took his foot off the brake, then braked noticing he still had a red light. Unit #2 failed to maintain a safe distance, and struck Unit #1 in the rear after accelerating with the green arrow. Both parties declined an OH-3.

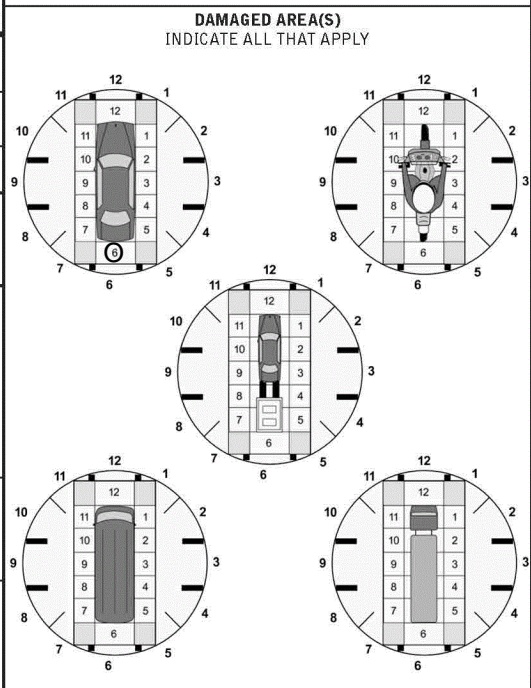

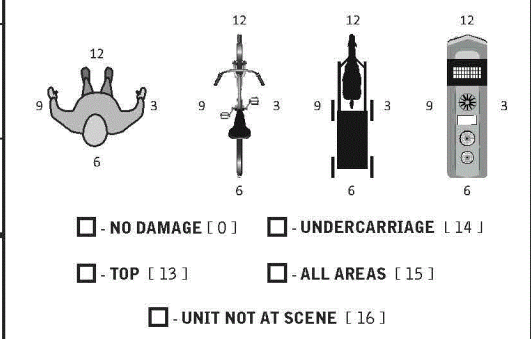

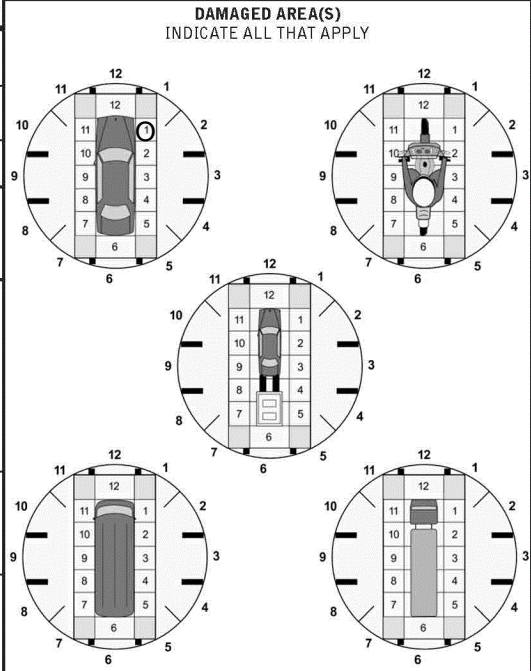
