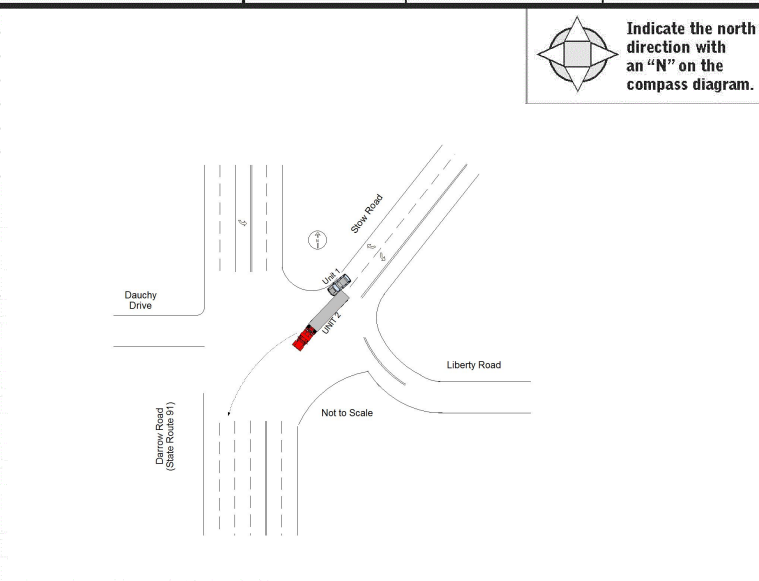

U#2 WAS AT THE SAME INTERSECTION BUT STOPPED IN THE LEFT TURN LANE PREPARING TO TURN SOUTH ON S.R. 91. WHEN THE SIGNAL TURNED GREEN, U#2 STARTED TO TURN SOUTH BUT TURNED TOO WIDE, CAUSING THE FLATBED TO ENTER THE RIGHT TRAFFIC LANE AND SIDE SWIPE U#1.
