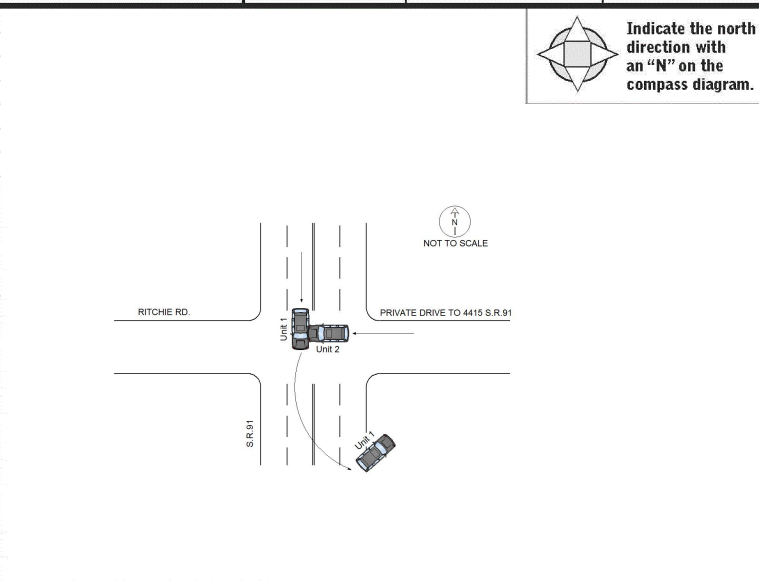

UNIT #1 WAS TRAVELING SOUTHBOUND ON S.R.91 IN THE RIGHT LANE AT THE INTERSECTION OF RITCHIE RD. UNIT #2 WAS TRAVELING WESTBOUND, EXITING A PRIVATE DRIVE ONTO S.R.91 NEAR RITCHIE RD. UNIT #2 FAILED TO YIELD RIGHT OF WAY WHEN EXITING A PRIVATE DRIVE, STRIKING UNIT #1 TO THE SIDE. UNIT #1 THEN RAN OFF THE ROAD LEFT. AFTERWARDS, WHILE ATTEMPTING TO MOVE UNIT #2 OUT OF THE ROADWAY, THE FRONT LEFT TIRE POPPED.

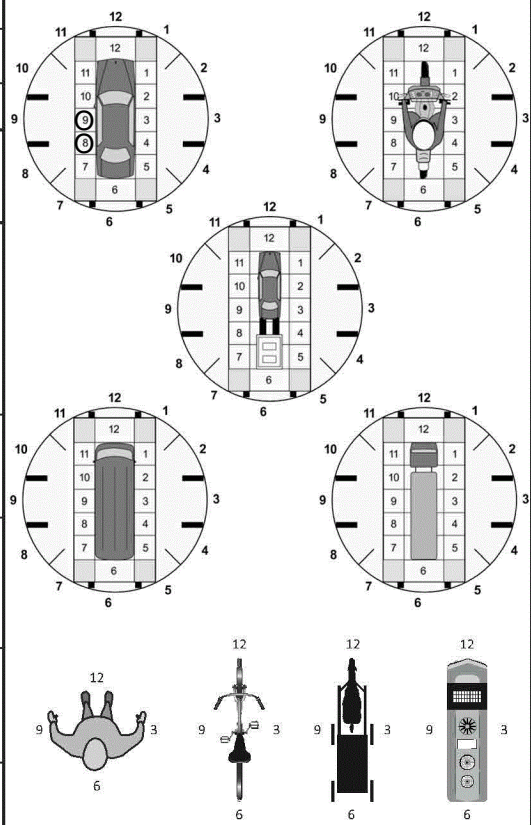
