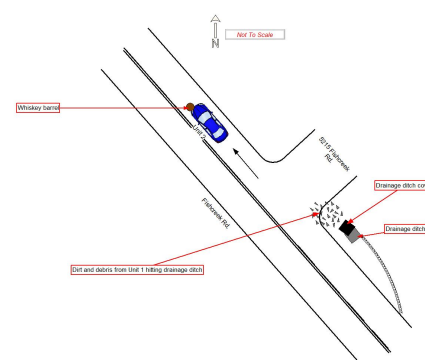
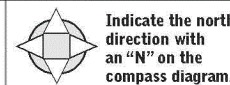

NARRATIVE
Unit 1 was traveling northwest on Fishcreek Rd. when it went off the roadway to the right. After leaving the roadway it struck a drainage ditch cover sliding it off. After striking the cover it projected a whiskey barrel yard decoration into the roadway and fled the scene. Unit 2 was traveling northwest on Fishcreek Rd. sometime later. The driver was being signaled by the witness but could not see the barrel that was in their lane of travel. Unable to navigate out of their lane at the last second Unit 2 struck the barrel with their front bumper.
