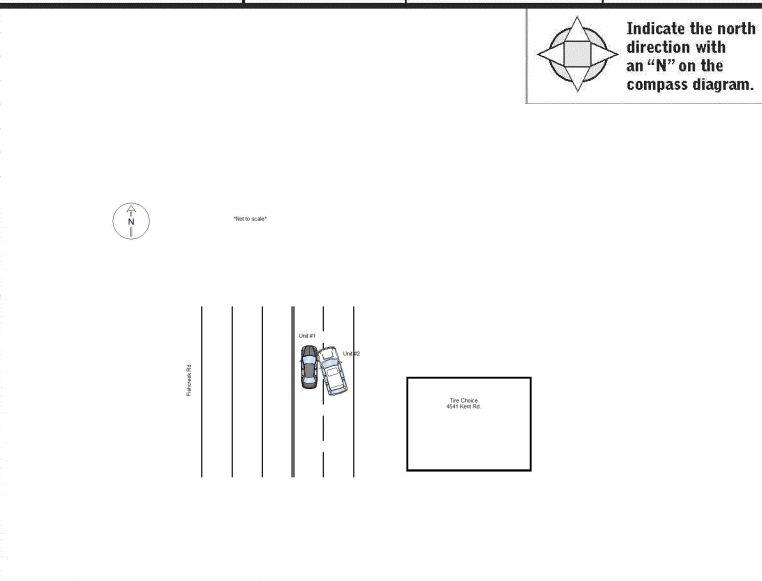

NARRATIVE

Unit #1 was northbound on Fishcreek Rd. near the intersection of Kent Rd. in the left lane. Unit #2 pulled out of Tire Choice 4541 Kent Rd. from the Fishcreek Rd. exit and got into the right lane. Unit #2's driver stated he attempted to make a U-turn from the right lane to head back to Kent Rd. and did not see Unit #1. Unit #2 struck Unit #1 as a result. The bumper from Unit #2 was partially torn off from the crash. Unit #2's driver was waiting for his boss to arrive to see if they should tow the vehicle so it is unknown if they had the vehicle towed.
